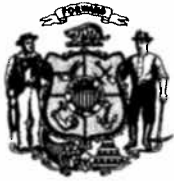
*In a given year, a school may only apply for preaccreditation through one agency listed in 119.23(2)7.

- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 8, line 1: after "summer school." insert "In any school year, a private
- 3 school may apply for and seek to obtain preaccreditation from only one of the entities
- 4 enumerated in this subdivision. A private school that fails to obtain accreditation
- 5 in a school year may apply for and seek to obtain preaccreditation from one of the
- 6 entities enumerated in this subdivision in the following school year."
- 7 **2.** Page 15, line 7: delete "school, and achieves" and substitute "school, and
- 8 achieves. In any school year, a private school may apply for and seek to obtain
- 9 preaccreditation from only one of the entities enumerated in this subd. 7. b. A private check Δ
- 10 school that fails to obtain accreditation in a school year may apply for and seek to

1 obtain preaccreditation from one of the entities enumerated in this subd. 7. b. in the
2 following school year. The private school shall achieve”.
