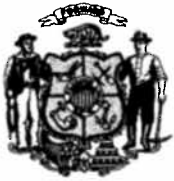

118.60 (2) (a) 7. b. A private school may not obtain preaccreditation and accreditation from the same accrediting entity."


