1 At the locations indicated, amend the bill as follows:

2 1. Page 6, line 10: after that line insert:

3 "SECTION 7m. Nonstatutory provisions.

4 (1) Upon the enactment of the 2012 fiscal year budget for Milwaukee County,
5 the county executive shall certify to the secretary of administration the amount of
6 the total aggregate appropriations for the functions of the Milwaukee County
7 treasurer and the Milwaukee County comptroller, as created in this act, that are
8 derived from property tax and sales tax revenues, and from fees paid to the treasurer
9 or comptroller. In paying for the functions of the treasurer and the comptroller
10 during the county's 2012 fiscal year, Milwaukee County may not exceed the amount
11 certified."
