## 2011 ASSEMBLY BILL 113

1     **AN ACT** *to amend* 2.01 (24) and 2.01 (39); and *to create* 992.22 of the statutes;  
2             **relating to:** changing the boundaries of Marquette County and Green Lake  
3             County.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

4             **SECTION 1.** 2.01 (24) of the statutes is amended to read:  
5             2.01 **(24)** GREEN LAKE: Beginning at the southwest corner of township 14, of  
6             range 11 east; and running thence east on the township line to the range line between  
7             ranges 13 and 14 east; thence north on said range line to the northeast corner of  
8             township 17, of range 13 east; thence west on the township line to the northeast  
9             corner of section 3, of township 17, of range 11 east; thence south along the east lines  
10            of sections 3, 10, 15, 22, 27, and 34 of township 17 of range 11 east and the east lines

1 of sections 3 and 10 of township 16 of range 11 east to the north line southeast corner  
2 of section 10 of township 16, of range 11 east, and to the northeast corner of section  
3 3 in the said last-named township; thence west along the township line to the half  
4 section corner of section 4 in township 16, of range 11 east; thence south to the south  
5 line of said section 4; thence east to the northeast corner of section 9 in township 16;  
6 thence south to the southeast corner of section 9; thence west to the half section  
7 corner of sections 9 and 16 along the south lines of sections 9 and 10 of township 16  
8 of range 11 east to the north one-quarter corner of section 16; thence south through  
9 the center of sections 16, 21, 28 and 33 to the township line between townships 15  
10 and 16; thence east along said township line to the northeast corner point where the  
11 center of the Fox River crosses said township line between sections 4 and 33 of the  
12 last named townships; thence southerly and easterly along the center of the Fox  
13 River to the point where the center of said river crosses the east line of section 3, in  
14 township 15, of range 11 east; thence south on the section line east lines of sections  
15 3, 10, 15, and 22 of township 15 of range 11 east to Lake Puckaway; thence westerly  
16 along the shore of said lake as meandered by the original government survey to the  
17 east line of section 19 in township 15 of range 11 east; thence westerly to the  
18 northeast corner of government lot 5 in section 19 in township 15 of range 11 east;  
19 thence southerly and westerly along the easterly line of government lot 5 in section  
20 19 in township 15 of range 11 east to the south line of section 19 in township 15 of  
21 range 11 east; thence west on the south line of section 19 in township 15 of range 11  
22 east to the range line between ranges 10 and 11 east; thence south on said range line  
23 to the place of beginning.

24 **SECTION 2.** 2.01 (39) of the statutes is amended to read:

1           2.01 (39) MARQUETTE: Beginning at the northeast corner of section 3 in  
2 township 17, of range 11 east of the meridian aforesaid; running thence south along  
3 the east lines of sections 3, 10, 15, 22, 27, and 34 of township 17 of range 11 east and  
4 the east lines of sections 3 and 10 of township 16 of range 11 east to the north line  
5 southeast corner of section 10 of township 16, of range 11 east, and to the northeast  
6 corner of section 3 in said last-mentioned township; thence west along the township  
7 line to the half section corner of section 4 in said township 16; thence south to the  
8 south line of said section 4; thence east to the northeast corner of section 9 in said  
9 last-mentioned township; thence south to the southeast corner of said section 9;  
10 thence west to the half section corner of sections 9 and 16 along the south lines of  
11 sections 9 and 10 of township 16 of range 11 east to the north one-quarter corner of  
12 section 16 of said last-mentioned township; thence south through the center of  
13 sections 16, 21, 28 and 33 to the township line between townships 15 and 16; thence  
14 east along said last-mentioned line to the northeast corner point where the center  
15 of the Fox River crosses said township line between sections 4 and 33 of the last  
16 named townships; thence southerly and easterly along the center of the Fox River  
17 to the point where the center of the said river crosses the east line of section 3 in  
18 township 15, range 11 east; thence south on the section-line east lines of sections 3,  
19 10, 15, and 22 of township 15 of range 11 east to Lake Puckaway; thence westerly  
20 along the shore of said lake, as meandered by the original government survey, to the  
21 east line of section 19 in township 15 of range 11 east; thence westerly to the  
22 northeast corner of government lot 5 in section 19 in township 15 of range 11 east;  
23 thence southerly and westerly along the easterly line of government lot 5 in section  
24 19 in township 15 of range 11 east to the south line of section 19 in township 15 of  
25 range 11 east; thence west on the south line of section 19 in township 15 of range 11

1 east to the range line between ranges 10 and 11 east; thence south on said range line  
2 to the township line between townships 13 and 14; thence west on said last-named  
3 township line to the southwest corner of township 14, range 8 east; thence north on  
4 the range line to the northwest corner of township 17, range 8 east; thence east on  
5 the township line to the place of beginning.

6 **SECTION 3.** 992.22 of the statutes is created to read:

7 **992.22 Validation of actions; Green Lake County and Marquette**  
8 **County boundaries.** Any action, proceeding, transaction, conveyance, or other  
9 matter which occurred before the effective date of this section .... [LRB inserts date],  
10 in Green Lake County or Marquette County, and related to or would have been  
11 impacted by the boundaries of these 2 counties, shall be considered to have occurred  
12 within the boundaries of Green Lake County or Marquette County as the boundaries  
13 of the 2 counties are described in s. 2.01 (24) and (39) on the effective date of this  
14 section .... [LRB inserts date].
