SENATE SUBSTITUTE AMENDMENT 1,
TO 2011 SENATE BILL 109

June 14, 2011 - Offered by Senators LEIBHAM, WIRCH, WANGGAARD, HOPPER, COWLES,
S. FITZGERALD and KAPANKE.

1 AN ACT *to amend* 940.20 (1) and 946.41 (2r); and *to create* 946.41 (2t) of the
2 statutes; **relating to:** causing soft tissue injury or great bodily harm to a law
3 enforcement officer when resisting or obstructing arrest, soft tissue injury
4 caused by a prisoner, and providing penalties.

*The people of the state of Wisconsin, represented in senate and assembly, do
enact as follows:*

5 SECTION 1. 940.20 (1) of the statutes is amended to read:

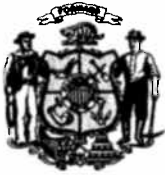
6 940.20 (1) BATTERY BY PRISONERS. Any prisoner confined to a state prison or
7 other state, county, or municipal detention facility who intentionally causes bodily
8 harm or a soft tissue injury to an officer, employee, visitor, or another inmate of such
9 prison or institution, without his or her consent, is guilty of a Class H felony.

10 SECTION 2. 946.41 (2r) of the statutes is amended to read:

11 946.41 (2r) Whoever violates sub. (1) and causes substantial bodily harm or a
12 soft tissue injury to an officer is guilty of a Class H felony.

TO 2011 SENATE BILL 109

October 3, 2011 - Offered by Representative ENDSLEY.

1 At the locations indicated, amend the bill, as shown by senate substitute
2 amendment 1, as follows:

3 1. Page 1, line 8: after "soft tissue injury" insert ", as defined in s. 946.41 (2)
4 (c)".

5 2. Page 1, line 10: before that line insert:

6 "SECTION 1g. 946.41 (2) (c) of the statutes is created to read:

7 946.41 (2) (c) "Soft tissue injury" means an injury that requires medical
8 attention to a tissue that connects, supports, or surrounds other structures and
9 organs of the body and includes tendons, ligaments, fascia, skin, fibrous tissues, fat,
10 synovial membranes, muscles, nerves, and blood vessels".
