

Subject: Amendments for ASA 1 to SB 116

Amendment 1 - Maintain current law and keep September primary as the 2nd Tuesday in September.

Amendment 2 -ASA 1 provides that all absentee electors except those voting in person have until 4 pm on the Friday after the election for their ballots to be received if the ballots are postmarked by election day. Maintain current current law.

Amendment 3 - ASA 1 states that a military elector who requests an absentee ballot receives absentee ballot automatically for all elections held in the same calendar year in the the request is made.

→Amendment 4 - require the body of a municipality must establish polling places 47 calendar days before each regularly scheduled election.

Amendment 5 - Require municipal clerks to:

- Ensure that SVRS is updated with correct polling place information at least 30 days before each election (except if there is less than 30 days between elections, then this update is required no later than week after the previous election)

- Notify County Clerk about polling place changes at least 30 days before each election

- Notify all candidates for offices affected by the change, for which the municipal clerk is the filing officer, by either email, phone, fax, in person, or letter at least 30 days before each election

- Post a notice at each polling place that has been closed since the previous election on election day
