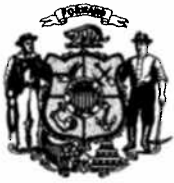

TO ASSEMBLY SUBSTITUTE AMENDMENT 1,
TO 2011 ASSEMBLY BILL 30**

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 3, line 1: delete that line and substitute:

3 **SECTION 1d.** 48.235 (1) (h) of the statutes is created to read:

4 48.235 (1) (h) The court shall appoint a guardian ad litem for any child who is
5 the subject of a delegation of power regarding the care and custody of the child to an
6 agent under s. 48.979.

7 **SECTION 1f.** 48.235 (3) (c) of the statutes is created to read:

8 48.235 (3) (c) In addition to any other duties and responsibilities required of
9 a guardian ad litem, a guardian ad litem appointed for a child who is the subject of
10 a delegation of power regarding the care and custody of the child to an agent under
11 s. 48.979 shall do all of the following unless granted leave by the court not to do so:

1 I, ... (name and address of guardian ad litem)[✓], have met with and interviewed

 3 reviewed this delegation of parental powers, and, based on those interviews and that
