3 "SECTION 1g. 16.705 (1x) of the statutes is created to read:

4 16.705 (1x) If an agency contracts with an attorney for legal services, the
5 agency may not pay to that attorney a rate that exceeds 3 times the rate paid to a
6 private local attorney under s. 977.08 (4m) (c) for time spent in court."

7 2. Page 2, line 1: delete "SECTION 1" and substitute "SECTION 1r".
