8 **SECTION 72.** 281.36 (3b) (a) of the statutes is created to read:

9 281.36 **(3b)** (a) For purposes of this section, a wetland general or individual
10 permit issued by the department constitutes water quality certification as required
11 by 33 USC 1341 (a).

12 **SECTION 73.** 281.36 (3g) (title) of the statutes is created to read:

13 281.36 **(3g)** (title) WETLAND GENERAL PERMITS.

14 **SECTION 74.** 281.36 (3g) (a) of the statutes is created to read:

15 281.36 **(3g)** (a) *Required permits.* The department shall issue a wetland
16 general permit for each of the following types of discharges:

17 1. A discharge that is necessary for the treatment or disposal of hazardous
18 waste or toxic pollutants, if the discharge does not contain hazardous waste or toxic
19 pollutants and does not affect more than 2 acres of wetland.

20 2. A discharge that is necessary for temporary access and dewatering, if the
21 discharge does not affect more than 2 acres of wetland.

22 3. A temporary or permanent discharge for routine utility construction and
23 maintenance projects and activities.

24 4. A discharge that is part of a development for industrial purposes, if the
25 discharge does not affect more than 10,000 square feet of wetland. For purposes of

1 this subdivision, the development of a waste disposal site is considered to be a
2 development for industrial purposes.

3 5. A discharge that is part of a development for commercial purposes, if the
4 discharge does not affect more than 10,000 square feet of wetland.

5 6. A discharge that is part of a development for residential purposes, if the
6 discharge does not affect more than 10,000 square feet of wetland.

7 7. A discharge that is part of a development for agricultural purposes, if the
8 discharge does not affect more than 10,000 square feet of wetland.

9 8. A discharge that is part of a development for municipal purposes, if the
10 discharge does not affect more than 10,000 square feet of wetland.

11 9. A discharge that is part of a development for recreational purposes, if the
12 discharge does not affect more than 10,000 square feet of wetland.

13 10. A discharge that is necessary for the construction, reconstruction, or
14 maintenance of a bridge or culvert that is part of a transportation project that is
15 being carried out under the direction and supervision of a city, village, town, or
16 county.

17 **SECTION 75.** 281.36 (3g) (c) of the statutes is created to read:

18 281.36 **(3g)** (c) *Additional permits.* The department may issue wetland general
19 permits, in addition to those required under pars. (a) and (b), to regulate other
20 discharges that affect wetlands located in this state.

21 **SECTION 76.** 281.36 (3g) (d) of the statutes is created to read:

22 281.36 **(3g)** (d) *Requirements; conditions; restrictions.* In issuing wetland
23 general permits under this subsection, the department shall establish requirements,
24 conditions, and exceptions to ensure that the discharges will cause only minimal
25 adverse environmental effects, and a general permit may apply only to a single and

1 complete project. As part of a general permit, the department may prohibit
2 discharges into wetlands that are identified by the department as being one of the
3 following:

4 1. Great Lakes ridge and swale complexes.

5 2. Interdunal wetlands.

6 3. Coastal plain marshes.

7 4. Emergent marshes containing wild rice.

8 5m. Sphagnum bogs that are located in the area located south of a horizontal
9 line drawn across the state based on the routes of STH 16 and STH 21 west of Lake
10 Winnebago and on USH 151 east of Lake Winnebago.

11 6. Boreal rich fens.

12 7. Calcareous fens.

13 **SECTION 77.** 281.36 (3g) (e) of the statutes is created to read:

14 281.36 **(3g)** (e) *Period of validity; subsequent actions.* A wetland general permit
15 issued under this subsection is valid for a period of 5 years. Upon compliance with
16 the requirements under pars. (f) to (g), the department may renew, modify, or revoke
17 a wetland general permit issued under this subsection.

18 **SECTION 78.** 281.36 (3g) (f) of the statutes is created to read:

19 281.36 **(3g)** (f) *Public notice.* The department shall provide to interested
20 members of the public notices of its intention to issue, renew, modify, or revoke a
21 wetland general permit under this subsection. Procedures for providing public
22 notices shall include all of the following:

23 1. Publication of a class 1 notice under ch. 985.

24 2. Providing a copy of the notice to any person or group upon request of the
25 person or group.

1 3. Publication of the notice on the department’s Internet Web site.

2 **SECTION 79.** 281.36 (3g) (fg) of the statutes is created to read:

3 281.36 **(3g)** (fg) *Date of notice.* For the purpose of determining the date on
4 which public notice is provided under this subsection, the date on which the
5 department first publishes the notice on its Internet Web site shall be considered the
6 date of public notice.

7 **SECTION 80.** 281.36 (3g) (fm) of the statutes is created to read:

8 281.36 **(3g)** (fm) *Written comments.* The department shall provide a period of
9 not less than 30 days after the date of the public notice during which time interested
10 persons may submit their written comments on the department’s intention to issue,
11 renew, modify, or revoke a wetland general permit under this subsection. All written
12 comments submitted during the period for comment shall be retained by the
13 department and considered by the department in acting on the general permit.

14 **SECTION 81.** 281.36 (3g) (fr) of the statutes is created to read:

15 281.36 **(3g)** (fr) *Description in notice.* Every public notice provided by the
16 department under par. (f) shall include a description of the discharges to be
17 authorized under the wetland general permit.

18 **SECTION 82.** 281.36 (3g) (g) of the statutes is created to read:

19 281.36 **(3g)** (g) *Public informational hearing.* 1. The department shall provide
20 an opportunity for any interested state agency or federal agency or person or group
21 of persons to request a public informational hearing with respect to the department’s
22 intention to issue, renew, modify, or revoke a wetland general permit under this
23 subsection. The request for the hearing shall be filed with the department within 30
24 days after the provision of the public notice under par. (f) and shall indicate the
25 interest of the party filing the request and the reasons why the hearing is warranted.

1 2. The department shall hold a public informational hearing upon a request
2 under subd. 1. if the department determines that there is a significant public interest
3 in holding such a hearing. Hearings held under this subsection are not contested
4 cases under s. 227.01 (3).

5 3. Public notice of any hearing held under this subsection shall be circulated
6 in accordance with the requirements under par. (f). The public notice shall include
7 the time, date, and location of the hearing, a summary of the subject matter of the
8 wetland general permit, and information indicating where additional information
9 about the general permit may be viewed on the department's Internet Web site. The
10 summary shall contain a brief, precise, easily understandable, plain language
11 description of the subject matter of the general permit.

12 **SECTION 83.** 281.36 (3g) (h) of the statutes is created to read:

13 281.36 **(3g)** (h) *Authorizations for discharges under wetland general permits.*

14 1. A person wishing to proceed with a discharge that may be authorized under a
15 wetland general permit shall apply to the department, with written notification of
16 the person's wish to proceed, not less than 30 days before commencing the discharge
17 authorized by the general permit unless subd. 4. applies. The application shall
18 provide information describing the discharge in order to allow the department to
19 determine whether the discharge is authorized by the wetland general permit and
20 shall give the department consent to enter and inspect the site, subject to sub. (9).
21 The application shall identify all activities affecting wetlands that will be conducted
22 as part of the single and complete project. The application shall include a detailed
23 explanation of why the impact to the wetland cannot be avoided and how the impact
24 to the wetland will be minimized to the greatest extent practicable. The application
25 shall be accompanied by the fee specified in sub. (12) (a). If the application is for

1 authorization to proceed under a wetland general permit that is issued under sub.
2 (3g) (a) 4., 5., or 6., the application shall be accompanied by a surcharge fee, as
3 calculated under sub. (11). The department may make a request for additional
4 information one time during this 30–day period.

5 2. If, within 30 days after an application under subd. 1. is received by the
6 department, the department does not either request additional information or
7 inform the applicant that a wetland individual permit will be required as provided
8 in par. (i), the discharge shall be considered to be authorized under the wetland
9 general permit and the applicant may proceed without further notice, hearing,
10 permit, or approval if the discharge is carried out in compliance with all of the
11 conditions of the general permit.

12 2m. If adverse weather conditions prevent the department from conducting an
13 accurate on–site inspection during this 30–day period specified in subd. 1., the
14 department shall give notice to the person wishing to proceed with the discharge that
15 adverse weather conditions will prevent the department from complying with the
16 30–day deadline and shall complete the inspection as soon as weather conditions
17 permit.

18 3. If the department requests additional information under subd. 1., the
19 30–day period is tolled from the date the person applying for authorization to proceed
20 receives the request until the date on which the department receives all of the
21 additional information.

22 4. As part of a wetland general permit issued under par. (b) or (c), the
23 department may waive the requirement that a person wishing to proceed under the
24 general permit apply to the department as required under this paragraph so that the

1 person may proceed with the discharge without specific authorization from the
2 department.

3 5. Authorization to proceed under a wetland general permit is valid for 5 years
4 after the date on which the discharge is considered to be authorized or until the
5 discharge is completed, whichever occurs first.

6 **SECTION 84.** 281.36 (3g) (i) of the statutes is created to read:

7 281.36 (3g) (i) *Wetland individual permit in lieu of wetland general permit.* For
8 a proposed discharge for which an application has been received by the department
9 under par. (h), the department may decide to require that a person who submitted
10 the application apply for a wetland individual permit if the department has
11 inspected the site as provided in par. (h) and has determined that conditions specific
12 to the site require additional restrictions on the discharge in order to provide
13 reasonable assurance that no significant adverse impacts to wetland functional
14 values will occur.

15 **SECTION 85.** 281.36 (3m) of the statutes is created to read:

16 281.36 (3m) WETLAND INDIVIDUAL PERMITS. (a) *When permit required.* Any
17 person wishing to proceed with a discharge into any wetland shall submit an
18 application for a wetland individual permit under this subsection unless the
19 discharge has been authorized under a wetland general permit as provided in sub.
20 (3g) or is exempt under sub. (4). The department shall hold a preapplication meeting
21 with the potential applicants to discuss the details of the proposed discharge and the
22 requirements for submitting the application and for delineating the wetland. As part
23 of the preapplication meeting, the department shall identify and establish the scope
24 of the analysis of practicable alternatives that will be required. An applicant may
25 include in the application a request for a public informational hearing. The

1 application shall be accompanied by the applicable fee specified in sub. (11) or (12)

2 (a).

3 (b) *Analysis of practicable alternatives.* An applicant shall include in an
4 application submitted under par. (a) a proposed analysis explaining the practicable
5 alternatives that were considered to first avoid and then minimize the adverse
6 impacts of the discharge on wetland functional values and that will not result in any
7 other significant adverse environmental consequences. The application shall also
8 include a description of the proposed mitigation method as required under sub. (3r).

9 (c) *Review; no additional information required.* In issuing wetland individual
10 permits under this section, the department shall review an application, and within
11 30 days after the application is submitted, the department shall determine that
12 either the application is complete or that additional information is needed. If the
13 department determines that the application is complete, the department shall notify
14 the applicant in writing of that fact within the 30-day period, and the date on which
15 the notice under this paragraph is sent shall be considered the date of closure for
16 purposes of par. (g) 1.

17 (d) *Additional information requested.* If the department determines that the
18 application is incomplete, the department shall notify the applicant in writing and
19 may make only one request for additional information during the 30-day period
20 specified in par. (c). Within 10 days after receiving all of the requested information
21 from the applicant, the department shall notify the applicant in writing as to
22 whether the application is complete. The date on which the 2nd notice under this
23 paragraph is sent shall be set as the date of closure for purposes of par. (g) 1. The
24 department may request additional information from the applicant to supplement
25 the application, but the department may not request items of information that are

1 outside the scope of the original request unless the applicant and the department
2 both agree. A request for any such additional information may not affect the date
3 of closure.

4 (e) *Specificity of notice; limits on information.* Any notice stating that an
5 application has been determined to be incomplete or any other request for
6 information that is sent under par. (d) shall state the reason for the determination
7 or request and the specific items of information that are still needed.

8 (f) *Failure to meet time limits.* If the department fails to meet the 30–day time
9 limit under par. (c) or 10–day time limit under par. (d), the application shall be
10 considered to have a date of closure that is the last day of that 30–day or 10–day time
11 period for purposes of par. (g) 1.

12 (g) *Notice of application.* 1. Within 15 days after the date of closure, as
13 determined under par. (c) or (d), the department shall provide notice of pending
14 application to interested members of the public. If the applicant has requested a
15 public informational hearing as part of the submitted application, a notice of the
16 public hearing shall be part of the notice of pending application.

17 2. If the notice of pending application does not contain a notice of public
18 informational hearing, any person may request a public informational hearing in
19 writing or the department may decide to hold a public informational hearing with
20 or without a request being submitted if the department determines that there is a
21 significant public interest in holding a hearing.

22 (h) *Request for hearing.* A request for a public informational hearing under par.
23 (g) 2. must be submitted to the department or the department’s decision to hold a
24 public informational hearing must occur within 20 days after the department
25 provides the notice of pending application. The department shall provide notice of

1 public informational hearing within 15 days after the request for the public hearing
2 is submitted or the department makes its decision to hold a public informational
3 hearing.

4 (i) *Decision.* Within 20 days after the period for public comment under par. (j)
5 has ended or if no public informational hearing is held, within 30 days after the
6 30–day comment period under par. (j) has ended, the department shall render a
7 decision issuing or denying the wetland individual permit that is the subject of the
8 application submitted under par. (a). If the decision issued by the department under
9 this paragraph is a denial, the department shall include in the decision the specific
10 grounds and reasons as to how the applicable provisions of this section were not met.
11 If the denial is based on an incomplete application, the department shall inform the
12 applicant of the areas of the application that were incomplete.

13 (j) *Public comment.* 1. The department shall provide a period for public
14 comment after the department has provided a notice of pending application under
15 par. (g) during which time any person may submit written comments with respect
16 to the application for a wetland individual permit. The department shall retain all
17 of the written comments submitted during this period and shall consider all of the
18 comments in rendering a decision on the application. The period for public comment
19 shall end on the 30th day following the date on which the department provides the
20 notice of pending application except as provided in subd. 2.

21 2. If a public informational hearing is held, the period for public comment shall
22 end on the 10th day following the date on which the hearing is completed.

23 **SECTION 86.** 281.36 (3n) of the statutes is created to read:

24 281.36 **(3n)** REVIEW BY DEPARTMENT. (a) *Review limits.* For the purpose of
25 issuing a wetland individual permit, during the period between the date on which

1 the application under sub. (3m) (a) is submitted and the date on which a decision
2 under sub. (3m) (i) is rendered, the department shall conduct its review under this
3 subsection. The department shall review the analysis of practicable alternatives
4 presented in the application under sub. (3m) (b). The department shall limit the
5 scope of the practicable alternatives that will be considered and shall determine
6 which possible alternatives are practicable in a manner that is consistent with the
7 memorandum of understanding entered into between the U.S. environmental
8 protection agency and the U.S. army corps of engineers relating to the level of
9 analysis required for evaluating compliance with 1333 USC 1344b that is in effect
10 on the effective date of this paragraph [LRB inserts date]. In order for an
11 alternative that would be implemented at a site that is not owned by the applicant
12 at the time the application is submitted and that would be located more than
13 one-half mile from the discharge to be considered practicable, the applicant must be
14 reasonably able to acquire, expand into, or otherwise manage the site in a manner
15 that will fulfill the basic purpose of the proposed discharge or the proposed project
16 of which the proposed discharge would be a part. The department also shall limit its
17 review to those practicable alternatives that are located at the site of the discharge
18 and that are located adjacent to that site if the applicant has demonstrated that the
19 proposed project is necessary for the expansion of an existing industrial, commercial,
20 or agricultural facility that is in existence at the time the application is submitted,
21 or that the proposed project will occur in an industrial park that is in existence at the
22 time the application is submitted.

23 (am) *Standards for issuing permits.* The department shall make a finding that
24 a proposed project causing a discharge is in compliance with water quality standards

1 and that a wetland individual permit may be issued if the department determines
2 that all of the following requirements are met:

3 1. The proposed project represents the least environmentally damaging
4 practicable alternative taking into consideration practicable alternatives that avoid
5 wetland impacts.

6 2. All practicable measures to minimize the adverse impacts to wetland
7 functional values will be taken.

8 3. The proposed project will not result in significant adverse impact to wetland
9 functional values, in significant adverse impact to water quality, or in other
10 significant adverse environmental consequences.

11 (b) *Factors to be used.* In making a determination that the requirement under
12 par. (am) 3. is met, the department shall consider all of the following factors:

13 1. The direct impacts of the proposed project to wetland functional values.

14 2. The cumulative impacts attributable to the proposed project that may occur
15 to wetland functional values based on past impacts or reasonably anticipated
16 impacts caused by similar projects in the area affected by the project.

17 3. Potential secondary impacts of the proposed project to wetland functional
18 values.

19 4m. The impact that any mitigation required under sub. (3r) will cause to the
20 functional values of the wetlands that are located in the watershed in which the
21 discharge will occur.

22 5m. The net positive or negative environmental impact of the proposed project
23 on the watershed in which the discharge will occur.

24 6. Whether there will be more than a minimal impact from the proposed project
25 on flood control or wildlife habitat.

1 (d) *Mitigation required.* The department shall require mitigation under the
2 program established under sub. (3r) for wetland individual permits it issues under
3 this subsection. This subsection does not entitle an applicant to a wetland individual
4 permit or any other approval in exchange for conducting mitigation.

5 **SECTION 87.** 281.36 (3p) of the statutes is created to read:

6 **281.36 (3p)** NOTICE REQUIREMENTS; WETLAND INDIVIDUAL PERMITS. (a) The
7 department shall establish procedures for providing notices of pending applications
8 and notices of public informational hearings to be provided under sub. (3m) and
9 notices of administrative hearings under sub. (3q). The procedures shall require all
10 of the following:

11 1. That the notice be published as a class 1 notice under ch. 985.

12 2. That the notice be provided to any person or group upon request of the person
13 or group.

14 3. That the notice be published on the department's Internet Web site.

15 (b) The department shall prescribe the form and content of notices of pending
16 applications and notices of public informational hearings to be provided under sub.
17 (3m) and notices of administrative hearings under sub. (3q). Each notice shall
18 include all of the following information:

19 1. The name and address of the applicant.

20 2. A brief description of the discharge that requires the permit and the project
21 that includes the discharge.

22 3. For a notice of a public informational hearing, the time, date, and location
23 of the hearing.

24 4. For a notice of pending application and a notice of a public informational
25 hearing, a brief, precise, easily understandable, plain-language description of the

1 discharge and information indicating where the pending application may be viewed
2 on the department's Internet Web site.

3 5. For a notice of complete application and a notice of a public informational
4 hearing, a statement of the tentative determination of the department on the permit.

5 6. For a notice of complete application and a notice of public informational
6 hearing, a brief description of the procedures for the formulation of final
7 determinations, including a description of the comment period required under sub.
8 (3m) (j).

9 (c) For the purpose of determining the date on which notice is provided under
10 this subsection, the date of the notice shall be the date on which the department first
11 publishes the notice on its Internet Web site, unless the department delegates to the
12 applicant under par. (d) the requirement to provide notice. If the department
13 delegates to the applicant the requirement to provide notice, the date of the notice
14 shall be the date on which the department first publishes the notice on its Internet
15 Web site or 10 days after the date on which the department receives satisfactory proof
16 of publication of a class 1 notice from the applicant, whichever is later.

17 (d) The department may delegate the department's requirement to provide
18 notice under sub. (3m) in the manner specified in par. (a) 1. and 2. by doing any of
19 the following:

20 1. Requiring that the applicant for the permit provide by publication, mailing,
21 or other distribution one or more of the notices.

22 2. Requiring that the applicant for the permit pay for the publication, mailing,
23 or any other distribution costs of providing one or more of the notices.

24 **SECTION 88.** 281.36 (3q) of the statutes is created to read:

1 281.36 **(3q)** ADMINISTRATIVE AND JUDICIAL REVIEW. (a) *Definition.* In this
2 subsection, “applicant” means any person applying for a wetland individual permit
3 under this section or any person who has been issued such a permit under this
4 section.

5 (b) *Request for administrative review.* Any interested person may file a petition
6 with the department for administrative review within 30 days after any of the
7 following decisions given by the department:

8 1. The issuance, denial, or modification of any wetland individual permit issued
9 under this section

10 2. The imposition of, or failure to impose, a condition on any wetland individual
11 permit issued under this section.

12 (c) *Content of the petition.* If the petitioner is not the applicant, the petition
13 shall describe the petitioner’s objection to the wetland individual permit and shall
14 contain all of the following:

15 1. A description of the objection that is sufficiently specific to allow the
16 department to determine which provisions of this section may be violated if the
17 proposed discharge under the wetland individual permit is allowed to proceed.

18 2. A description of the facts supporting the petition that is sufficiently specific
19 to determine how the petitioner believes the discharge, as proposed, may result in
20 a violation of the provisions of this section.

21 3. A commitment by the petitioner to appear at the administrative hearing and
22 present information supporting the petitioner’s objection.

23 (d) *Stays.* 1. The discharge shall be stayed pending an administrative hearing
24 under this subsection if the petition contains a request for the stay showing that a

1 stay is necessary to prevent significant adverse impacts or irreversible harm to the
2 environment.

3 2. If a stay is requested under subd. 1., the stay shall be in effect until either
4 the department denies the request for an administrative hearing or the hearing
5 examiner determines that the stay is not necessary.

6 (e) *Filings.* The petitioner shall file a copy of the petition with the department.
7 If the petitioner is not the applicant, the petitioner shall simultaneously provide a
8 copy of the petition to the applicant. The applicant may file a response to the petition
9 with the department. If the applicant files a response under this paragraph, it shall
10 be filed within 15 days after the petition is filed.

11 (f) *Action on petition.* The department shall grant or deny the petition within
12 30 days after the petition is filed. The failure of the department to dispose of the
13 petition within this 30–day period is a denial. The department shall deny the
14 petition if any of the following applies:

15 1. The petitioner is not the applicant, and the petition does not comply with the
16 requirements of par. (c).

17 2. The objection contained in the petition is not substantive. The department
18 shall determine that an objection is substantive if the supporting facts contained in
19 the objection appear to be substantially true and raise reasonable grounds to believe
20 that the provisions of this section may be violated if the activity or project is
21 undertaken.

22 3. If the department denies the petition, the department shall send the
23 petitioner the denial in writing, stating the reasons for the denial.

24 4. If the department grants a petition under this subsection, the department
25 shall refer the matter to the division of hearings and appeals in the department of

1 administration within 15 days after granting the petition unless the petitioner and
2 the applicant agree to an extension.

3 (g) *Administrative hearing.* 1. An administrative hearing under this
4 subsection shall be treated as a contested case under ch. 227.

5 2. If a stay under par. (d) 1. is in effect, the hearing examiner shall, within 30
6 days after receipt of the referral under par. (f) 4., determine whether continuation
7 of the stay is necessary to prevent significant adverse impacts or irreversible harm
8 to the environment pending completion of the administrative hearing. The hearing
9 examiner shall make the determination based on the request under par. (d) 1., any
10 response from the applicant under par. (e), and any testimony at a public hearing or
11 any public comments. The determination shall be made without a hearing.

12 3. An administrative hearing under this subsection shall be completed within
13 90 days after receipt of the referral of the petition under par. (f) 4., unless all parties
14 agree to an extension of that period. In addition, a hearing examiner may grant a
15 one-time extension for the completion of the hearing of up to 60 days on the motion
16 of any party and a showing of good cause demonstrating extraordinary
17 circumstances justifying an extension.

18 4. Notwithstanding s. 227.44 (1), the department shall provide a notice of the
19 administrative hearing at least 30 days before the date of the hearing to all of the
20 following:

21 a. The applicant.

22 b. Each petitioner, if other than the applicant.

23 c. Any other persons required to receive notice as provided under sub. (3p).

24 5. In an administrative hearing under this subsection, the petitioner shall
25 proceed first with the presentation of evidence and shall have the burden of proof.

1 (h) *Judicial review.* 1. Any person whose substantial interest is affected by a
2 decision of the department under par. (b) 1. or 2. may commence an action in circuit
3 court to review that decision.

4 2. Any party aggrieved by a decision of the hearing examiner under par. (g) may
5 commence an action in circuit court to review that decision.

6 **SECTION 89.** 281.36 (3r) of the statutes is created to read:

7 **281.36 (3r) MITIGATION; IN LIEU FEE SUBPROGRAM.** (a) The department shall
8 establish a mitigation program that applies only to the issuance of wetland
9 individual permits and that allows mitigation to be accomplished by any of the
10 following methods:

11 1. Purchasing credits from a mitigation bank located in this state.

12 2. Participating in the in lieu fee subprogram, if such a subprogram is
13 established under par. (e).

14 3. Completing mitigation within the same watershed or within one-half mile
15 of the site of the discharge.

16 (b) Under the mitigation program, mitigation as specified in par. (a) 1. and
17 participation in the in lieu fee subprogram, if established under par. (a) 2. shall be
