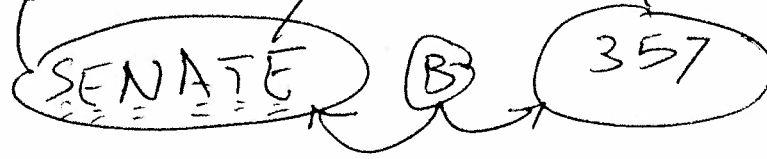

At the locations indicated, amend the bill as follows:

1. Page 2, line 4: delete "satisfies" and substitute "counts toward satisfying".
2. Page 2, line 13: after that line insert:

**"SECTION 3. Effective date.**

(1) This act takes effect on the first day of the 3rd month beginning after publication."

\*\*\*\*NOTE: In addition to amending AB-438 to include the delayed effective date as requested, the amendment also includes a technical change to clarify the intent of the bill. Specifically, the word "satisfies" is amended to read "counts toward satisfying" on page 2, line 4 of the bill to clarify that military training may satisfy all or a portion of a credential's training requirements. Is this change okay? Note that this clarification is also included as a part of LRBs0258/P1.
