ASSEMBLY AMENDMENT,

At the locations indicated, amend the bill as follows:

1. Page 2, line 11: after that line insert:

"Section 3m. 84.106 (3) of the statutes is created to read:

84.106 (3) Marking highways. Highways designated as scenic byways under this section may be marked with signs conforming with the manual of uniform traffic control devices adopted by the department under s. 84.02 (4) (e) that identify the highway as a scenic byway. The department shall have exclusive authority to erect these signs on state trunk highways the local authority with jurisdiction over the highway, for maintenance purposes, shall have exclusive authority to erect these

signs on local highways and connecting highways.". 10
