TO 2011 ASSEMBLY BILL 518

1 At the locations indicated, amend the bill as follows:

2 1. Page 2, line 11: after that line insert:

3 "SECTION 3m. 84.106 (3) of the statutes is created to read:

4 84.106 (3) MARKING HIGHWAYS. Highways designated as scenic byways under
5 this section may be marked with signs conforming with the manual of uniform traffic
6 control devices adopted by the department under s. 84.02 (4) (e) that identify the
7 highway as a scenic byway. The department shall have exclusive authority to erect

8 these signs on state trunk highways ~~and~~ the local authority with jurisdiction over the
9 highway, for maintenance purposes, shall have exclusive authority to erect these
10 signs on local highways and connecting highways.".
