Hello Tracy,

I have some changes for the amendment that you are working on for us. I apologize for this happening so late in the process.

Rather than saying which parts to keep and which not, I am just going to start from the top with a whole new amendment, so just disregard the previous amendment request.

- 1) In order to address concerns by the CRNAs, we would like to put two sections of language into Chapter 441. We are not sure where this would best fit would be. Here is the language we would like to see incorporated.
 - a. The requirement of s. 448.04(1)(g) do not apply to a nurse anesthetist, as defined in s. 655.001 (9)
 - b. A nurse in a training program to become a nurse anesthetist as defined in s.655.001(9), and who is assisting an anesthesiologists, as defined in s. 448.015(1b), as part of that program must be supervised by an anesthesiologist who is supervising no more than one other nurse in such a training program.
- 2) Page 9 line 14 starting after the word "program" please replace "to a qualified anesthesia provider." with "to only a qualified anesthesiologist, an anesthesiology fellow, an anesthesiology resident who has completed his or her first year of anesthesiology residency, or an anesthesiologist assistant, but in no case may an anesthesiologist concurrently supervise, either directly or as a delegated act, more than two anesthesiologist assistant students."
- 3) Lastly, in order to make one amendment possible, we would like to incorporate into this amendment the language from LRBa2305/1 (Assembly Amendment 1 to 2011 Assembly Bill 487) So, deleting the material that begins with "the promotion" and ending with "role" on line 24 of page 9 and substituting "promote the safe and competent practice".

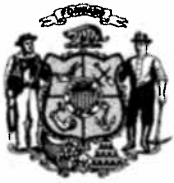
