TO 2011 ASSEMBLY BILL 224

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 3, line 2: after that line, on page 2, line 16, of the material inserted by  
3 assembly amendment 1, delete "The" and substitute "Subject to subd. 3. bm., the".

4 **2.** Page 3, line 2: after that line, after page 2, line 17, of the material inserted  
5 by assembly amendment 1, insert:

6 "bm. The library board's use of any disbursement made under subd. 3. a. shall  
7 be consistent with the intent of the donor of the gift, bequest, or endowment and with  
8 the agreement between the library board and the community foundation."

9 **3.** Page 3, line 19: after that line, on page 4, line 1, of the material inserted by  
10 assembly amendment 1, delete "The" and substitute "Subject to par. (bm), the".

11 **4.** Page 3, line 19: after that line, after page 4, line 2, of the material inserted  
12 by assembly amendment 1, insert:

① “(bm) The <sup>school</sup>library board’s use of any disbursement made under par. (a) shall be  
2 consistent with the intent of the donor of the gift, bequest, or endowment and with  
③ the agreement between the <sup>school</sup>library board and the community foundation.”.

4 **5.** Page 4, line 9: after that line, on page 5, line 6, of the material inserted by  
5 assembly amendment 1, delete “The” and substitute “Subject to subd. 2m., the”.

6 **6.** Page 4, line 9: after that line, after page 5, line 7, of the material inserted  
7 by assembly amendment 1, insert:

⑧ “2m. The <sup>school</sup>library board’s use of any disbursement made under subd. 1. shall be  
9 consistent with the intent of the donor of the gift, bequest, or endowment and with  
⑩ the agreement between the <sup>school</sup>library board and the community foundation.”.
