SENATE AMENDMENT 1, TO 2011 ASSEMBLY BILL 224

1/10/12 worked today (early 1.m.)

December 16, 2011 - Offered by Senator Olsen.

At the locations indicated, amend the bill as follows:

1. Page 3, line 2: after that line, on page 2, line 16, of the material inserted by assembly amendment 1, delete "The" and substitute "Subject to subd. 3. bm., the".

2. Page 3, line 2: after that line, after page 2, line 17, of the material inserted by assembly amendment 1, insert:

"bm. The library board's use of any disbursement made under subd. 3. a. shall be consistent with the intent of the donor of the gift, bequest, or endowment and with the agreement between the library board and the community foundation.".

- **3.** Page 3, line 19: after that line, on page 4, line 1, of the material inserted by assembly amendment 1, delete "The" and substitute "Subject to par. (bm), the".
- **4.** Page 3, line 19: after that line, after page 4, line 2, of the material inserted by assembly amendment 1, insert:

"(bm) The school board's use of any disbursement made under par. (a) shall be
consistent with the intent of the donor of the gift, bequest, or endowment and with
the agreement between the school board and the community foundation.".
5. Page 4, line 9: after that line, on page 5, line 6, of the material inserted by
assembly amendment 1, delete "The" and substitute "Subject to subd. 2m., the".
6. Page 4, line 9: after that line, after page 5, line 7, of the material inserted
by assembly amendment 1, insert:
"2m. The school board's use of any disbursement made under subd. 1. shall be
consistent with the intent of the donor of the gift, bequest, or endowment and with
the agreement between the school board and the community foundation.".
