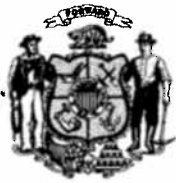

TO ASSEMBLY AMENDMENT 4,
TO ASSEMBLY SUBSTITUTE AMENDMENT 1,
TO 2011 ASSEMBLY BILL 311**

1 At the locations indicated, amend the amendment as follows:

2 **1.** Page 2, line 5: delete lines 5 and 6 and substitute *No 9*

3 "or a portion of a state park if any of the following applies:

4 1. The department prohibits hunting, fishing, or trapping in a designated use
5 area.

6 2. The natural resources board determines that prohibiting hunting, fishing,
7 or trapping is necessary to protect public safety or to protect a unique animal or".

8 **2.** Page 2, line 8: before "requires" insert "under this subdivision".
