***The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:***

7           **SECTION 1.** 15.347 (21) of the statutes is created to read:

8           15.347 (21) SPORTING HERITAGE COUNCIL. (a) There is created in the department  
9           of natural resources a sporting heritage council consisting of the following members:

10           1. The secretary of natural resources, or his or her designee, who shall serve  
11           as chairperson.

12           2. One member, appointed by the governor.

13           3. Two members, <sup>of the assembly</sup> appointed by the speaker of the assembly, who may not be  
14           members of the same political party.

15           4. Two members, <sup>of the senate</sup> appointed by the senate majority leader, who may not be  
16           members of the same political party.

17           5. Five members, appointed by the secretary of natural resources <sup>board</sup> from  
18           nominations provided by sporting organizations that have as their primary objective

19           the promotion of hunting <sup>or fishing,</sup> or trapping. Of the 5 members, one shall represent the  
20           interests of deer hunters, one shall represent the interests of bear hunters, one shall

21           represent the interests of waterfowl <sup>bird</sup> hunters, one shall represent the interests of  
22           upland game hunters <sup>or</sup> and one shall represent the interests of furbearing animal

23           hunters and trappers. <sup>anglers</sup>

1           6. One member, appointed by the executive committee of the conservation  
2 congress, who is a member of the conservation congress.

3           (b) The members of the sporting heritage council appointed under par. (a) 2. to  
4 6. shall be appointed for 3-year terms.

5           (c) The sporting heritage council shall meet at least one time each year.

6           **SECTION 2.** 23.0916 (3m) of the statutes is created to read:

7           23.0916 **(3m)** BOARD DETERMINATIONS. (a) Except as provided in par. (b), a  
8 determination by the natural resources board under sub. (2) (b) or (c) or (3) (b) or (c)  
9 with regard to public access on land or an easement requires 4 or more members of  
10 the natural resources board to concur in that determination if the land or easement  
11 was acquired on or after the effective date of this paragraph ... [LRB inserts date].

12           (b) Paragraph (a) does not apply to a determination by the natural resources  
13 board with regard to public access on an easement, if the primary purpose of the  
14 easement is to provide public access to a navigable water on which public fishing is  
15 allowed.

24           **29.036 Sporting heritage council.** (1) The sporting heritage council shall  
25 study, and provide advice and make recommendations to the governor, the natural

3 (a) Ways to improve the recruitment and retention of hunters, trappers, and  
4 anglers.

5 (b) Ways to improve the management and protection of the natural resources  
6 of this state for the purposes of hunting, trapping, fishing, and other types of outdoor  
7 recreation activities.

8 (c) Ways to encourage youth to participate in outdoor recreation activities,  
9 including ways to implement outdoor recreation programs for youth.

11 fishing, and other types of outdoor recreation activities.

12 (e) Ways to improve public access to lakes.

13 (f) Ways to increase the availability of public shooting ranges.

14 (2) The sporting heritage council shall prepare a biennial report on the status  
15 of the recruitment and retention of hunters, trappers, and anglers in this state. The  
16 sporting heritage council shall submit its initial report under this subsection no later  
17 than July 1, 2014, and shall submit subsequent reports no later than July 1 of each  
18 even-numbered year thereafter, to the governor, to the chairperson of the natural  
19 resources board, and to the chief clerk of each house of the legislature, for  
20 distribution to the appropriate standing committees under s. 13.172 (3).

7 program to recognize people who recruit others as hunters, trappers, and anglers.  
8 The program shall include a component under which a person who is issued his or  
9 her first hunting, trapping, or fishing approval in his or her lifetime may designate  
10 one person as the person who encouraged the applicant to obtain the license. The  
11 program shall provide for all of the following:

12 (1) A method for maintaining a record of persons designated as provided under  
13 this section.

14 (2) A method for issuing a credit to any resident who is designated as provided  
15 under this section a specified number of times, as determined by the department, in  
16 any license year. The method shall require the department to allow the recipient of  
17 the credit to apply the credit in a manner that reduces the fee for an approval that  
18 is listed under s. 29.563 (2) (a) 1., 2., 4. to 5g., or 7. to 9., (3) (a) 1., or (6) (a) 1. by  
19 one-half of the fee that would otherwise apply to the approval, rounded up to the  
20 nearest dollar, that reduces the fee specified in s. 29.563 (4) (a) 1. for a resident sports  
21 license by \$20, or that reduces the fee specified in s. 29.563 (4) (a) 2. for a resident

1 motor bus, as defined in s. 340.01 (31), subject to the admission requirements under  
2 s. 27.01 (7) in any vehicle admission area under s. 27.01 (7) without having an  
3 admission receipt affixed to the vehicle or otherwise displayed and without paying  
4 a fee if the vehicle has as an occupant a card holder who can present the card upon  
5 demand in the vehicle admission area. The card permits a card holder to enter  
6 Heritage Hill state park or a state trail without paying an admission fee.

7 (3) Except as provided in this section, possession of an annual disabled veteran  
8 recreation card shall not entitle the holder to obtain any other privileges or services  
9 for free if the privileges or services may be obtained only through payment of a fee.

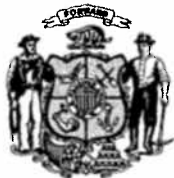
