- 5 notification system, the department may require that the person who kills a wolf
- 6 physically present the entire carcass to the department for registration."
- 7 **3.** Page 9, line 5: after "department" insert ", or the department may require
- 8 the person to physically present the entire carcass to the department for
- 9 registration."
