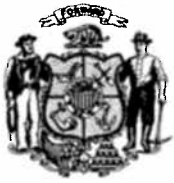

TO 2011 ASSEMBLY BILL 502

SENATE BILL 411

1 At the locations indicated, amend the bill as follows:

2 1. Page 5, line 23: delete that line and substitute "and ends 30 minutes after  
3 sunset on December 31 of the same year."

4 2. Page 7, line 5: delete that line and substitute "deer with firearms and ending  
5 30 minutes after sunset on December 31 of the same year."

6 3. Page 7, line 14: delete lines 14 and 15 and substitute "hunting deer with  
7 firearms and ending 30 minutes after sunset on December 31 of the same year."

8 4. Page 8, line 19: delete the material beginning with that line and ending with  
9 page 9, line 5.
