Analysis by the Legislative Reference Bureau

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

18 There is created a ~~barbering and cosmetology~~ examining board in the department of
 19 safety and professional services. The ~~barbering and cosmetology~~ examining board
 20 shall consist of 9 members appointed for 4-year terms. Four members shall be
 21 licensed ~~barbers~~, aestheticians, or cosmetologists, 2 members shall be public

1 members, one member shall be a representative of a private school of ~~barbering or~~
2 cosmetology, one member shall be a representative of a public school of ~~barbering or~~
3 cosmetology and one member shall be a licensed electrologist. Except for the 2
4 members representing schools, no member may be connected with or have any
5 financial interest in a ~~barbering or~~ cosmetology school.

5 8. Satisfies the requirements for schools of ~~barbering~~ or cosmetology
6 established in rules promulgated under subs. (2) (e) and (5) (b) 1. and s. 440.64 (1)
7 (b).

14 of instruction may not exceed 8 training hours in any one day for any student or 48

18 of at least 150 training hours of theoretical instruction.

21 those apprentices the completion of at least 288 training hours in not less than 9
22 weeks and not more than 2 years.

23 5. Satisfies the requirements for schools of barbering established in rules

23 agreement under sub. (2) between the department and the licensing authority in the
24 state where the applicant is licensed.

1 **(2)** The department may enter into a reciprocal agreement with the officials of
2 another state for the licensing of barbers in this state and may grant a license to a
3 person licensed in the other state according to the terms of that agreement.

4 **454.28 Inspections. (1)** The department shall appoint inspectors under the
5 classified service to inspect licensed barbering establishments.

6 **(2)** An inspector appointed under sub. (1) may enter and inspect any licensed
7 barbering establishment at any time during business hours.

8 **454.285 Disclosure of temporary permit status.** A person practicing under
9 a temporary permit to practice barbering granted under s. 454.23 (7) shall, before
10 performing any barbering services, inform the person receiving the barbering service
11 that he or she is practicing under a temporary permit and that he or she has satisfied
12 all requirements except passage of an examination for a barbering license.

13 **454.287 Advisory committee.** The secretary shall appoint an advisory
14 committee under s. 440.042 to advise the department on matters relating to the
15 regulation of barbers, barbering managers, and barbering establishments under this
16 subchapter and the rules required under s. 440.62 (5) (b) 2.

17 **454.29 Disciplinary proceedings and actions. (1)** Subject to the rules
18 promulgated under s. 440.03 (1), the department may make investigations or
19 conduct hearings to determine whether a person has violated this subchapter or any
20 rule promulgated under this subchapter.

21 **(2)** Subject to the rules promulgated under s. 440.03 (1) and this subchapter,
22 the department may revoke, limit, suspend, or refuse to issue or renew, in accordance
23 with the severity of the violation, a license or temporary permit granted under this
24 subchapter or reprimand the holder of a license or temporary permit granted under

1 this subchapter if the department finds that the holder or applicant has done any of
2 the following:

3 (a) Made a material misstatement in an application for a license, renewal of a
4 license, or temporary permit.

5 (b) Failed to correct or take substantial steps approved by the department to
6 correct a violation of any sanitary or other rule of the department within the time
7 limit stated by the department in a notification of violation.

8 (c) Engaged in conduct in the practice of barbering that evidences a lack of
9 knowledge or ability to apply professional principles or skills.

10 (d) Subject to ss. 111.321, 111.322, and 111.335, been convicted of a felony
11 committed while engaged in the practice of barbering.

12 (e) Continued practice while knowingly having an infectious, contagious, or
13 communicable disease.

14 (f) Advertised in a manner that is false, deceptive, or misleading.

15 (g) Advertised, practiced, or attempted to practice under another's name or
16 another's trade name.

17 (h) Subject to ss. 111.321, 111.322, and 111.34, been addicted to alcohol or other
18 drugs to an extent related to the individual's ability to adequately undertake the
19 job-related responsibilities of that individual's licensure.

20 (i) Violated this subchapter or any rule promulgated under this subchapter.

21 **(3)** The department may, in addition to or in lieu of a reprimand or revocation,
22 limitation, suspension, or denial of a license or temporary permit, assess against a
23 person who has done any of the things under sub. (2) (a) to (i) a forfeiture of not more
24 than \$1,000 for each separate offense. Each day of continued violation constitutes
25 a separate offense.

1 **454.295 Penalties.** Any person who violates this subchapter or any rule
2 promulgated under this subchapter shall be fined not less than \$100 nor more than
3 \$5,000 or imprisoned for not less than 10 days nor more than 90 days or both.

4 **SECTION 102. Nonstatutory provisions.**

5 (1) TREATMENT OF CURRENT LICENSED BARBERS OR COSMETOLOGISTS, MANAGERS,
6 ESTABLISHMENTS, AND SCHOOLS OF BARBERING OR COSMETOLOGY AND CURRENT CERTIFIED
7 BARBERING OR COSMETOLOGY INSTRUCTORS.

8 (a) *Definition.* In this subsection, “department” means the department of
9 safety and professional services.

10 (b) *Barbers.* Notwithstanding section 454.23 (1) and (2) of the statutes, as
11 created by this act, and subject to a notification and renewal under this paragraph,
12 on the effective date of this paragraph, a person who, immediately prior to the
13 effective date of this paragraph, held a valid barber or cosmetologist license granted
14 by the barbering and cosmetology examining board, is considered to be a licensed
15 barber, as defined in section 454.20 (7) of the statutes, as created by this act. The
16 department shall issue a barber license to that person under section 454.23 (2) of the
17 statutes, as created by this act, if the person notifies the department that the person
18 intends to practice as a barber subject to subchapter II of chapter 454 of the statutes,
19 as created by this act, and satisfies the applicable renewal requirements for a barber
20 license under section 440.08 of the statutes, as affected by this act, before April 1,
21 2013.

22 (c) *Cosmetologists.* Notwithstanding section 454.06 (1) and (2) of the statutes,
23 as affected by this act, and subject to a notification and renewal under this
24 paragraph, on the effective date of this paragraph, a person who, immediately prior
25 to the effective date of this paragraph, held a valid barber or cosmetologist license

1 granted by the barbering and cosmetology examining board, is considered to be a
2 licensed cosmetologist, as defined in section 454.20 (10) of the statutes, as created
3 by this act. The cosmetology examining board shall issue a cosmetologist license to
4 that person under section 454.06 (2) of the statutes, as affected by this act, if the
5 person notifies the cosmetology examining board that the person intends to practice
6 as a cosmetologist subject to subchapter I of chapter 454 of the statutes, as created
7 by this act, and satisfies the applicable renewal requirements for a cosmetologist
8 license under section 440.08 of the statutes, as affected by this act, before April 1,
9 2013.

10 (d) *Barbering managers.* Notwithstanding section 454.23 (1) and (3) of the
11 statutes, as created by this act, and subject to a notification and renewal under this
12 paragraph, on the effective date of this paragraph, a person who, immediately prior
13 to the effective date of this paragraph, held a valid manager license granted by the
14 barbering and cosmetology examining board, is considered to be a licensed barbering
15 manager, as defined in section 454.20 (9) of the statutes, as created by this act. The
16 department shall issue a barbering manager license to that person under section
17 454.23 (3) of the statutes, as created by this act, if the person notifies the department
18 that the person intends to practice as a barbering manager subject to subchapter II
19 of chapter 454 of the statutes, as created by this act, and satisfies the applicable
20 renewal requirements for a barbering manager license under section 440.08 of the
21 statutes, as affected by this act, before April 1, 2013.

22 (e) *Cosmetology managers.* Notwithstanding section 454.06 (1) and (3) of the
23 statutes, as affected by this act, and subject to a notification and renewal under this
24 paragraph, on the effective date of this paragraph, a person who, immediately prior
25 to the effective date of this paragraph, held a valid manager license granted by the

1 barbering and cosmetology examining board, is considered to be a licensed
2 cosmetology manager, as defined in section 454.20 (12) of the statutes, as created by
3 this act. The cosmetology examining board shall issue a cosmetology manager
4 license to that person under section 454.06 (3) of the statutes, as affected by this act,
5 if the person notifies the cosmetology examining board that the person intends to
6 practice as a cosmetology manager subject to subchapter I of chapter 454 of the
7 statutes, as created by this act, and satisfies the applicable renewal requirements for
8 a cosmetology manager license under section 440.08 of the statutes, as affected by
9 this act, before April 1, 2013.

10 (f) *Barbering establishments.* Notwithstanding section 454.25 of the statutes,
11 as created by this act, and subject to a notification and renewal under this paragraph,
12 on the effective date of this paragraph, an establishment, as defined under section
13 454.01 (10) of the statutes, that, immediately prior to the effective date of this
14 paragraph, held a valid barbering or cosmetologist establishment license granted by
15 the barbering and cosmetology examining board, is considered to be a licensed
16 barbering establishment, as defined in section 454.20 (8) of the statutes, as created
17 by this act. The department shall issue a barbering establishment license for that
18 establishment under section 454.25 (2) of the statutes, as created by this act, if an
19 authorized representative of the establishment notifies the department that the
20 establishment will be maintained as a barbering establishment subject to
21 subchapter II of chapter 454 of the statutes, as created by this act, and the applicable
22 renewal requirements for a barbering establishment license under section 440.08 of
23 the statutes, as affected by this act, are satisfied for the establishment before April
24 1, 2013.

1 (g) *Cosmetology establishments.* Notwithstanding section 454.08 of the
2 statutes, as affected by this act, and subject to a notification and renewal under this
3 paragraph, on the effective date of this paragraph, an establishment, as defined
4 under section 454.01 (10) of the statutes, as affected by this act, that, immediately
5 prior to the effective date of this paragraph, held a valid barbering or cosmetologist
6 establishment license granted by the barbering and cosmetology examining board,
7 is considered to be a licensed cosmetology establishment, as defined in section 454.20
8 (11) of the statutes, as created by this act. The cosmetology examining board shall
9 issue a cosmetology establishment license for that establishment under section
10 454.08 (2) (a) of the statutes, as affected by this act, if an authorized representative
11 of the establishment notifies the cosmetology examining board that the
12 establishment will be maintained as a cosmetology establishment subject to
13 subchapter I of chapter 454 of the statutes, as created by this act, and the applicable
14 renewal requirements for a cosmetology establishment license under section 440.08
15 of the statutes, as affected by this act, are satisfied for the establishment before April
16 1, 2013.

17 (h) *Schools of barbering.* Notwithstanding section 440.62 (3) (ag) of the
18 statutes, as created by this act, and subject to a notification and renewal under this
19 paragraph, on the effective date of this paragraph, a school, as defined in section
20 440.60 (14) of the statutes, as affected by this act, that, immediately prior to the
21 effective date of this paragraph, held a valid school of barbering or cosmetology
22 license granted by the department, is considered to be a licensed school of barbering
23 under subchapter VI of chapter 440 of the statutes, as affected by this act. The
24 department shall issue a school of barbering license to that school under section
25 440.62 (3) (ag) of the statutes, as created by this act, if an authorized representative

1 of the school notifies the department that the school will be maintained as a school
2 of barbering subject to subchapter VI of chapter 440 of the statutes, as affected by
3 this act, and the applicable renewal requirements for a school of barbering license
4 under section 440.08 of the statutes, as affected by this act, are satisfied for the school
5 before April 1, 2013.

6 (i) *Schools of cosmetology.* Notwithstanding section 440.62 (3) (ar) of the
7 statutes, as created by this act, and subject to a notification and renewal under this
8 paragraph, on the effective date of this paragraph, a school, as defined in section
9 440.60 (14) of the statutes, as affected by this act, that, immediately prior to the
10 effective date of this paragraph, held a valid school of barbering or cosmetology
11 license granted by the department is considered to be a licensed school of cosmetology
12 under subchapter VI of chapter 440 of the statutes, as affected by this act. The
13 department shall issue a school of barbering license to that school under section
14 440.62 (3) (ar) of the statutes, as created by this act, if an authorized representative
15 of the school notifies the department that the school will be maintained as a school
16 of cosmetology subject to subchapter VI of chapter 440 of the statutes, as affected by
17 this act, and the applicable renewal requirements for a school of cosmetology license
18 under section 440.08 of the statutes, as affected by this act, are satisfied for the school
19 before April 1, 2013.

20 (j) *Barbering instructors.* Notwithstanding section 440.63 (3) (a) of the
21 statutes, as affected by this act, and subject to a notification and renewal under this
22 paragraph, on the effective date of this paragraph, a person who, immediately prior
23 to the effective date of this paragraph, held a valid barbering or cosmetology
24 instructor certificate granted by the department, is considered to be a certified
25 barbering instructor under subchapter VI of chapter 440 of the statutes, as affected

1 by this act. The department shall issue a barbering instructor certificate to that
2 person under section 440.63 (3) (a) of the statutes, as affected by this act, if the person
3 notifies the department that the person intends to act as a barbering instructor
4 subject to subchapter VI of chapter 440 of the statutes, as affected by this act, and
5 satisfies the applicable renewal requirements for a barbering instructor certificate
6 under section 440.08 of the statutes, as affected by this act, before April 1, 2013.

7 (k) *Cosmetology instructors.* Notwithstanding section 440.63 (3) (am) of the
8 statutes, as created by this act, and subject to a notification and renewal under this
9 paragraph, on the effective date of this paragraph, a person who, immediately prior
10 to the effective date of this paragraph, held a valid barbering or cosmetology
11 instructor certificate granted by the department, is considered to be a certified
12 cosmetology instructor under subchapter VI of chapter 440 of the statutes, as
13 affected by this act. The department shall issue a cosmetology instructor certificate
14 to that person under section 440.63 (3) (am) of the statutes, as created by this act,
15 if the person notifies the department that the person intends to act as a cosmetology
16 instructor subject to subchapter VI of chapter 440 of the statutes, as affected by this
17 act, and satisfies the applicable renewal requirements for a cosmetology instructor
18 certificate under section 440.08 of the statutes, as affected by this act, before April
19 1, 2013.

20 **SECTION 103. Effective date.**

21 (1) This act takes effect on July 1, 2012.
