SENATE AMENDMENT,  
TO 2011 SENATE BILL 388

1 At the locations indicated, amend the bill as follows:

2 1. Page 7, line 20: after that line insert:

3 "3m. If skiing, stay on the trails for which he or she has been determined to  
4 be qualified to use."

5 2. Page 11, line 13: after that line insert:

6 "(am) *Testing of ability*. Before issuing a ticket or a season pass to an individual  
7 who will be engaged in skiing, a ski area operator shall assess the level of skiing  
8 ability of the individual to determine which levels of trails he or she is qualified to  
9 use. The assessment shall be performed either by having the individual fill out a  
10 form containing questions to assess his ability or by skiing in the presence of an  
11 employee or agent of the ski area operator. The individual shall be issued a ticket  
12 or pass that is color-coded to show the difficulty levels of trails he or she is qualified  
13 to use."
