At the locations indicated, amend the substitute amendment as follows:

1. Page ~~(11)~~ line ~~(25)~~ after that line insert:

"(e) *Safe conditions.* Each ski area operator shall operate and maintain each ski area that the ski area operator owns or is responsible for in a reasonably safe condition."

2. Page ~~(14)~~ line ~~(15)~~: delete "restrictions on civil liability," and substitute "negligence;"

3. Page ~~(15)~~ line ~~(15)~~ delete lines ~~(15)~~ to ~~(19)~~ and substitute:

"(4) NEGLIGENCE; CIVIL ACTIONS. (A) A ski area operator who does not fulfill all of his or her duties under s. 167.33 (3) and (4) and a participant in a snow sport who does not fulfill all of his or her duties under s. 167.33 (5) is negligent."
