TO 2011 SENATE BILL 426

February 27, 2012 - Offered by Senators RISSER and ERPENBACH

At the locations indicated, amend the bill as follows:

- **1.** Page 3, line 10: delete "denied benefits" and substitute "determined to have committed an intentional program violation".
- 2. Page 3, line 11: delete "denial following" and substitute "determination following".
 - 3. Page 3, line 11: delete "denial is" and substitute "determination is".
 - **4.** Page 3, line 14: delete "denial." and substitute "determination. If an individual requests a review, including a contested case hearing, under this paragraph, benefits may not be denied under par. (a) before the review process is exhausted and the review results in a determination that the individual committed an intentional program violation.".
