11 enforcement operations related to all-terrain vehicles and utility terrain vehicles,
12 including actual enforcement, safety training, accident reporting, and similar
13 activities.

Some initial thoughts: You are right about Section 3. That provision should not have been in the draft. That provision was a remnant of an earlier approach when I was intending to change the name of the gas tax payment.

As for your suggestion, I don't see how this would work unless the draft creates a separate UTV gas tax payment under s. 25.29 (1). You are correct that the draft combines the ATV and UTV gas tax money so if you want to ensure that the UTV portion is only used on trails that allow UTVs, I think that it will be necessary to establish a UTV gas tax formula much like the ATV gas tax formula. But I will continue to give this some thought and we can talk tomorrow.

Robin-

We found a part of the /P4 draft this morning that needs to be revised. A number of e-mails have been flying around and you have been copied on some of them, so I just wanted to lay out for you here where we are.

There are two changes that need to be made to the /P4 draft when it is turned into a /1.

1. Section 7: There is an error in the cross-reference. Instead of cross-referencing s. 25.29 (1)(dr) it should cross-reference s. 25.29(1)(dm).
2. Section 3: The basic problem here is that when this section appropriates money from the conservation fund for ATV/UTV recreation aids, it does not create segregated accounts for the gas tax reimbursement money. Under Sections 164-166, we are lumping UTV and ATV gas tax money together when we deposit it into the conservation fund. However, when it comes out to be spent, it needs to be segregated. We do not want UTV gas tax reimbursement money being used on recreation aids for trails that do not allow UTVs.

So, the solution we have come up with is this- First, delete Section 3 from the draft. This will leave s. 20.370(5)(ct) as it exists under current law. ATV project aids will come out of the conservation fund based on the ATV gas tax reimbursement, without reference to UTVs. Second, we would then take care of the UTV portion by adding-in the UTV reimbursement for the gas tax under Section 5- UTV aids. I'm not sure how you would structure the language, but we

would like to add this to Section 5 in such a way as to apply the existing language in that section to UTV gas tax money. i.e. it would only be appropriated for trails that allow UTVs.

At least that's our idea. If there is a better way to draft it, you can do it a different way. Ultimately, we just don't want UTV gas tax money going to trails that don't allow UTVs.

I had several conversations with Lucas about the calculation of the gas tax formula. Because the desire is to have the UTV gas tax money only fund trails on which UTVs are allowed, I told Lucas that there would have to be a separate UTV gas tax formula. The question was what to do with the commercial registration part of the formula. Lucas said that I could talk to LFB about this issue. I called Erin Probst and she agree that a separate formula for ATVs and UTVs was probably necessary and that perhaps we could split the commercial registrations (e.g. 50%) toward each formula. She said that there were about 1500 commercial registrations in the last fiscal year.

I called Lucas again to tell him about this conversation and in the meantime he had spoken with Hank Wozniak. They decided to count all of the commercial registrations in the ATV formula and not include them at all in the UTV formula.

I also mentioned to him that the draft still refers to the trail passes as "nonresident" passes but under the draft, all users must have a pass. We agreed to remove the term "nonresident" from the description of the passes.
