TO 2011 ASSEMBLY BILL 429

SENATE 338

January 18, 2012 - Offered by Representative KOYENGA.

1 At the locations indicated, amend the bill as follows:

- 2 1. Page 6, line 15: substitute "(a)" for "1."
- 3 2. Page 6, line 16: substitute "(b)" for "2."
- 4 3. Page 6, line 17: substitute "(c)" for "3."

5 ~~#~~ Page 6, line 17: after "(f)" insert ", or one of the following:

6 1. A member of a reserve component of the U.S. armed forces or of the national
7 guard, as defined in 32 USC 101 (3), who has served under honorable conditions for
8 at least one year beginning on the member's date of enlistment in a reserve
9 component of the U.S. armed forces or ⁱⁿ of the national guard.

10 2. A person who was discharged from a reserve component of the U.S. armed
11 forces or from the national guard, as defined in 32 USC 101 (3), if that discharge was
12 an honorable discharge or a general discharge under honorable conditions." ✓
