- 5 "SECTION 1g. 146.355 of the statutes is created to read: ✓
- 6 **146.355 Prescription of erectile dysfunction medication.** No person may
- 7 prescribe for a man a medication to treat erectile dysfunction unless a physician
- 8 performs a rectal examination and a cardiac stress test on the man.".
- 9 **3.** Page 3, line 1: delete "SECTION 1" and substitute "SECTION 1m". ✓
