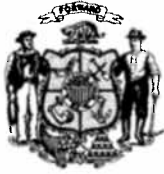

11 5. Children receiving evidence-based home visitation services achieving
12 milestones in development and early learning.

13 6. Children receiving evidence-based home visitation services who have
14 developmental delays receiving appropriate intervention services.

15 **SECTION 1x.** 48.983 (8) of the statutes is amended to read:

16 48.983 (8) TECHNICAL ASSISTANCE AND TRAINING. The department shall provide
17 technical assistance and training to counties, private agencies, and Indian tribes
18 that are selected to participate in the program under this section. The training may
19 not be limited to a particular evidence-based home visitation model. The training
20 shall include training in best practices regarding basic skills, uniform
21 administration of screening and assessment tools, the issues and challenges that
22 families face, and supervision and personnel skills for program managers. The
23 training may also include training on data collection and reporting.

24 **SECTION 1y.** 48.983 (9) of the statutes is created to read:

1 48.983 (9) MEMORANDUM OF UNDERSTANDING. The department shall enter into
2 a memorandum of understanding with the department of health services that
3 provides for collaboration between those departments in carrying out
4 evidence-based home visiting programs under sub. (4) (b) 1.

5 **SECTION 1z.** 49.45 (24w) of the statutes is created to read:

6 49.45 (24w) SERVICES FOR PREGNANT WOMEN. (a) The department shall request
7 a waiver of federal Medicaid law from the secretary of the federal department of
8 health and human services to permit the department to provide services and support
9 under medical assistance for pregnant women who face an increased risk of having
10 a low-birth weight baby, a preterm birth, or other negative birth outcome because
11 of medical or nonmedical factors, such as psychosocial, behavioral, environmental,
12 educational, or nutritional factors. The department shall implement the programs
13 and services authorized by this waiver in Milwaukee, Racine, Kenosha, Rock, and
14 Dane counties, and in a rural multicounty region identified by the department in
15 collaboration with the Great Lakes Intertribal Council. The multicounty region
16 shall include counties experiencing the largest disparities in birth outcomes between
17 Caucasian and Native American populations and shall be of sufficient size to enable
18 meaningful implementation and evaluation of the programs and services.

19 (b) The department shall consider including all of the following as covered
20 services or programs in the waiver request under par. (a):

21 1. Evidence-based social marketing of programs designed to reduce fetal and
22 infant mortality, improve birth outcomes, and address needs of infants and their
23 families.

24 2. Evidence-based social-support programs, including fatherhood initiatives
25 designed to reduce fetal and infant mortality and improve birth outcomes.

1 3. Transportation services for persons who accompany a pregnant woman to
2 prenatal appointments and transportation for the pregnant woman and her children
3 to other destinations including social services' offices and locations where child care
4 is provided for her children.

5 4. Data collection, including the pregnancy risk assessment and monitoring
6 system, fetal and infant mortality review, vital statistics information, information
7 from medical assistance data and chart reviews, and an assessment of nonmedical
8 factors that may contribute to poor birth outcomes.

9 5. Full reimbursement for evidence–based group prenatal care, such as the
10 Centering Pregnancy program.

11 6. Mental health services.

12 7. Smoking cessation services.

13 8. Initiatives to increase the utilization of public health and other health care
14 providers with similar racial and socioeconomic backgrounds as the pregnant women
15 and families served by the health care provider.

16 9. Coordinators to create social care plans for medical assistance recipients, to
17 provide information and assistance regarding all programs that may impact
18 low–income pregnant women, including programs regarding rental assistance, the
19 earned income tax credit, available child care services for a pregnant woman's other
20 children, and to provide breastfeeding support.

21 10. Demonstration projects developed by the department, to evaluate the
22 effectiveness of evidence–based programs designed to serve under–served
23 populations.

1 11. One or more initiatives, developed by the department, to increase the
2 utilization of nurse–midwives licensed under s. 441.15 (3) and doulas in the delivery
3 of care to underserved populations and to evaluate the outcomes of that care.

4 12. The establishment of freestanding birth centers.

5 13. Extension of the prenatal care coordination services that are available as
6 a medical assistance benefit from the beginning of pregnancy to the first day of the
7 13th month after delivery and specifying that prenatal care coordination services are
8 available to recipients' babies during that time period.

9 14. Expansion and full reimbursement of evidence–based, home–based
10 prenatal care coordination services.

11 15. Full reimbursement for home visits made by registered nurses who are
12 public health nurses or who meet the qualifications of a public health nurse as
13 specified in s. 250.06 (1), by social workers as defined in s. 252.15 (1) (er),
14 nurse–midwives licensed under s. 441.15 (3), and by persons who receive the training
15 established under s. 38.04 (32).

16 16. Reimbursement of care provided through telemedicine visits on the same
17 basis that reimbursement is provided for in–person visits.
