1 At the locations indicated, amend the bill as follows:

2 **1.** Page 1, line 5: before “repealing” insert “defining abortion,”.

3 **2.** Page 3, line 1: before that line insert:

4 “SECTION 1g. 253.10 (2) (a) of the statutes is amended to read:

5 253.10 (2) (a) “Abortion” means the use of an instrument, medicine, drug or
6 other substance or device with intent to terminate the pregnancy of a woman known
7 to be pregnant or for whom there is reason to believe that she may be pregnant and
8 with intent other than to increase the probability of a live birth, to preserve the life
9 or health of the infant after live birth or to remove a dead fetus. “Abortion” does not
10 include the use or prescription of a contraceptive drug or device approved by the
11 federal food and drug administration to prevent pregnancy.”.

2 include a contraceptive drug, medicine, oral hormonal compound, mixture, or
3 preparation, that is approved by the federal food and drug administration to prevent
4 pregnancy.".
