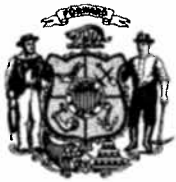

PRELIMINARY DRAFT - NOT READY FOR INTRODUCTION
ASSEMBLY AMENDMENT ,
TO 2011 SENATE BILL 306

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 1, line 6: delete “against women who perform or obtain” and substitute
3 “for performing or obtaining”.

4 **2.** Page 9, line 24: delete that line and substitute:

5 “SECTION 10d. 939.75 (2) (b) 1. of the statutes is amended to read:

6 939.75 (2) (b) 1. An act committed during an induced abortion. This
7 subdivision does not limit the applicability of ss. 940.04, 940.13, 940.15, and 940.16
8 to an induced abortion.

9 History: 1997 a. 295; 2001 a. 109; 2003 a. 97.

9 **SECTION 10r.** 940.04 of the statutes is repealed.”.
