1 AN ACT *to amend* 343.17 (3) (a) 2. of the statutes; **relating to:** photographs on  
2 operator's licenses.

***Analysis by the Legislative Reference Bureau***

Under current law, a motor vehicle operator's license must include a color photograph of the licensed person. Under this bill, the license must include a photograph of the licensed person, but the photograph need not be in color.

***The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:***

3 SECTION 1. 343.17 (3) (a) 2. of the statutes is amended to read:
