- 5 "SECTION 1g. 343.17 (1m) of the statutes is created to read:
- 6 343.17 (1m) LICENSE PRODUCTION. A license issued under this section shall be
- 7 produced in this state."
- 8 **3.** Page 1, line 3: delete "1" and substitute "1m".
- 9 **4.** Page 1, line 4: after that line insert:
- 10 "SECTION 2. 343.50 (1m) of the statutes is created to read:
- 11 343.50 (1m) PRODUCTION. An identification card issued under this section shall
- 12 be produced in this state."
