As we discussed on the phone; this is a relative easy fix. The word crossbow just needs to be added to 29.304 (1) (a). This will prevent the unintended consequence of an un-mentored hunter that is not yet 12 years old that *has* completed hunters ed or bow hunters ed from being able to hunt with a crossbow, but not a firearm or a bow and arrow. TO 2011 ASSEMBLY BILL 384

1 At the locations indicated, amend the bill as follows:

2 1. Page 5, line 18: after that line insert:

3 "SECTION 17. ^m 29.304 (1) (a) of the statutes is amended to read:

4 29.304 (1) (a) *Prohibition on hunting.* No person under 12 years of age may

5 hunt with a firearm ~~or~~, bow and arrow, or crossbow."
