As we discussed on the phone; this is a relative easy fix. The word crossbow just needs to be added to 29.304 (1) (a). This will prevent the unintended consequence of an un-mentored hunter that is not yet 12 years old that *has* completed hunters ed or bow hunters ed from being able to hunt with a crossbow, but not a firearm or a bow and arrow.
