At the locations indicated, amend the bill as follows:

1. Page 3, line 15: after that line insert:

"Section 5m. 29.171 (2m) of the statutes is amended to read:

29.171 **(2m)** Notwithstanding sub. (2), a resident archer hunting license authorizes hunting with a bow and arrow or with a crossbow if the licensee is a resident senior citizen has attained the age of 55. A resident senior citizen who has attained the age of 55 is not required to hold a permit from the department to hunt with a crossbow if the resident senior citizen he or she holds a license under this section.".

- **2.** Page 5, line 18: after that line insert:
- "Section 17. 29.216 (2m) of the statutes is amended to read:

29.216 **(2m)** Persons 65 55 Years of age or older. Notwithstanding sub. (2), a nonresident archer hunting license authorizes hunting with a bow and arrow or with

a crossbow if the licensee is a person who has attained the age of 65 55. A person who has attained the age of 65 55 is not required to hold a permit from the department to hunt with a crossbow if he or she holds a license under this section.".
