

Jim:

Peter Grant forwarded to me your drafting request to require that at least 6 members of the Wisconsin technical college system (WTCS) board must be employed by or own a private, for-profit business. I have a couple of questions about this request.

First, I assume that a "private" business could mean a corporation whose shares are publicly traded. Is that correct? In other words, "private" isn't intended to be limited to a corporation whose shares are privately held and not publicly traded, correct?

Second, when you refer to a board, do you mean the WTCS board, which oversees all of the tech. college districts, or do you mean each WTCS district board? Note that there is one WTCS board and 16 WTCS district boards.

Finally, I copied below a description of the membership of the WTCS board and the WTCS district boards from an LFB informational paper. How exactly do you want to change the membership of the board to accomplish your purpose? For example, if your intent is to change the membership of the WTCS board, and not the 16 district boards, how do you want to change the membership to require 6 for-profit business members? There are many possibilities. You could add 6 new members, or you could change the qualifications of the members under current law. For example, you could require the 6 public members to be for-profit business members, or you could do any number of other things. The same questions would apply if your intent is to change the membership of the 16 WTCS district boards, instead of the WTCS board.

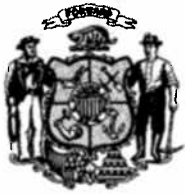

**Analysis by the Legislative Reference Bureau**

Under current law, the Wisconsin technical college system consists of 16 technical college districts, which are administered by district boards. Each district board has the following 9 members: 2 employers, 2 employees, one school district administrator, one elected state or local official, and 3 additional members. The employer and employee members must represent the various businesses and industries in the district. Members are appointed for 3-year terms by appointment committees consisting of either county board chairs or school board presidents.

This bill changes the membership of district boards so that they consist of the following 9 members: 6 business persons, one school district administrator, one elected state or local official, and one additional member. The bill defines "business person" as an owner, officer, director, member, manager, partner, operator, or employee of a business entity that is operated for profit or a retired person who, prior to retirement, earned a substantial portion of his or her income as the owner, officer, director, member, partner, operator, or employee of such a business entity. The bill does not otherwise affect the requirements for appointing members.

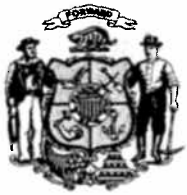

**Analysis by the Legislative Reference Bureau**

Under current law, the Wisconsin technical college system consists of 16 technical college districts, which are administered by district boards. Each district board has the following nine members: two employers, two employees, one school district administrator, one elected state or local official, and three additional members. The employer and employee members must represent the various businesses and industries in the district. Members are appointed for three-year terms by appointment committees consisting of either county board chairs or school board presidents.

This bill changes the membership of district boards so that they consist of the following nine members: six business persons, one school district administrator, one elected state or local official, and one additional member. The bill defines "business person" as an owner, officer, director, member, manager, partner, operator, or employee of a business entity that is operated for profit, a retired person who, prior to retirement, earned a substantial portion of his or her income as owner, officer,
