Vicky:

For each amendment, I need to know who should be on the appointment committee for the technical college district board members.

Under SSA 2, which applies only to the Milwaukee Area Technical College, the committee that appoints the district board members (i.e., the appointment committee) is the county executive of Milwaukee County and the chairpersons of the Milwaukee, Ozaukee, and Washington County boards of supervisors. Also, SSA 2 specifies that the county executive of Milwaukee County is the chairperson of the appointment committee.

What do you want to do about the appointment committee for other districts? Should the appointment committee consist of the chairperson of each county board of supervisors whose county is wholly or partially included within the district? What about county executives, administrators, administrative coordinators? (Not all counties have elected county executives, as some have county administrators or administrative coordinators who are hired by the board of supervisors.) Maybe you want to add the county executive or administrator of the county with the largest population within the district? That would be similar to SSA 2, which adds only the county executive of Milwaukee County to the appointment committee.

As for the chairperson of the appointment committee, maybe you want to specify that it should be the county executive, administrator, or administrative coordinator of the county with the largest population within the district?

Let me know your thoughts.

Mark -

Rep. Mason and other members of the Assembly Dem caucus need numerous amendments drafted to SB 275 Senate Second Substitute amendment 2.

1. There are 16 technical college districts in the state. The bill in its current form only applies to 1 district. We need 15 separate simple amendments that add each of the other 15 tech college districts to the bill. (i.e. simple amendment 1 to SB 275 SS 2 would add Gateway Technical College, simple amendment 2 to SB 275 SS2 would add the Fox Valley Technical College, etc. etc.)

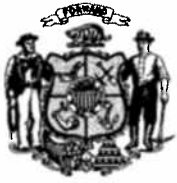
2. We also need a simple amendment to SB 275 SS2 that would strike MATC from the bill and make the bill apply to all technical college districts in the state.

I will have a series of very similar amendment requests expanding districts the bill will apply to that I will send you later this morning but I wanted to get you this part of the request right away.

Please let me know if you have any questions. This bill is expected to come over to the Assembly from the Senate today so we will need these amendments as soon as possible.

1 At the locations indicated, amend the bill, as shown by senate substitute  
2 amendment 2, as follows:

3 **1.** Page 1, line 5: after "Milwaukee area" insert "and Chippewa Valley".

4 **2.** Page 1, line 5: delete "board" and substitute "boards".

5 **3.** Page 2, line 10: after "Milwaukee area" insert "and Chippewa Valley".

6 **4.** Page 2, line 10: delete "board" and substitute "boards".

7 **5.** Page 2, line 11: delete "college" and substitute "colleges".

8 **6.** Page 3, line 4: after "college." insert "Notwithstanding pars. (a) to (c), the  
9 appointment committee for the district board governing the Chippewa Valley

10 technical college shall consist of the chairpersons of the board of supervisors of the

11 counties in whole or in part in the district and the county executive of the county

1 having the largest population in the district or, if that county does not have a county  
2 executive, the county administrator or administrative coordinator of that county.”.

3 **7.** Page 3, line 20: after “college.” insert “For the district board governing the  
4 Chippewa Valley technical college, <sup>Lakeshore</sup> the chairperson of the appointment committee  
5 shall be the county executive of the county having the largest population in the  
6 district or, if that county does not have a county executive, the county administrator  
7 or administrative coordinator of that county.”.

8 **8.** Page 5, line 10: after “college.” insert “The majority of the members of the  
9 appointment committee for the district board governing the Chippewa Valley <sup>Lakeshore</sup>  
10 technical college constitutes a quorum for that appointment committee, except that  
11 if that committee consists of an even number of members, a majority of the members  
12 plus one member constitutes a quorum for that committee.”.

13 **9.** Page 5, line 16: delete “board” and substitute “boards”.

14 **10.** Page 5, line 16: after “Milwaukee area” insert “and Chippewa Valley”.

15 **11.** Page 5, line 16: delete “college” and substitute “colleges”.
