9 (1) INITIAL ELECTION OF WESTERN TECHNICAL COLLEGE DISTRICT BOARDS. 10 Notwithstanding section 38.08 (6) of the statutes, as created by this act, within 60 11 days after the effective date of this subsection, the appointment committee of the 12 Western technical college district shall adopt and transmit to the secretary of the 13 district board and the director of the technical college system board an initial 14 districting plan for election districts as required by section 38.08 (6) of the statutes, 15 as created by this act. The technical college system board shall review and determine 16 its approval or disapproval of the plan as promptly as possible.
