



**ASSEMBLY AMENDMENT 68,
TO 2011 SENATE BILL 275**

March 15, 2012 – Offered by Representative MASON.

1 At the locations indicated, amend the bill, as shown by senate substitute
2 amendment 2, as follows:

3 **1.** Page 5, line 15: before “section 38.08 (1) (b) of the statutes” insert “section
4 38.08 (1) (a) 1g. of the statutes, as created by this act, and”.

5 **2.** Page 5, line 19: delete the material beginning with that line and ending with
6 page 6, line 20, and substitute:

7 “(am) Two of the members specified in section 38.08 (1) (a) 1g. a. of the statutes,
8 as created by this act, and one of the members specified in section 38.08 (1) (a) 1g.
9 d. of the statutes, as created by this act, shall have terms ending on June 30, 2016.
10 Of the members specified in section 38.08 (1) (a) 1g. a. of the statutes, as created by
11 this act, who are appointed under this paragraph, one member shall represent
12 employers with 15 or more employees and one member shall represent employers
13 with 100 or more employees and one of those members shall represent employers

1 who are manufacturing businesses. The members appointed under this paragraph
2 shall replace the members of the district board appointed under section 38.08 (1) (a)
3 1., 2009 stats., whose terms expire on June 30, 2013.

4 (bm) One of the members specified in section 38.08 (1) (a) 1g. a. of the statutes,
5 as created by this act, the member specified in section 38.08 (1) (a) 1g. c. of the
6 statutes, as created by this act, and one of the members specified in section 38.08 (1)
7 (a) 1g. d. of the statutes, as created by this act, shall have terms ending on June 30,
8 2017. The members appointed under this paragraph shall replace the members of
9 the district board appointed under section 38.08 (1) (a) 1., 2009 stats., whose terms
10 expire on June 30, 2014.

11 (cm) Two of the members specified in section 38.08 (1) (a) 1g. a. of the statutes,
12 as created by this act, and the member specified in section 38.08 (1) (a) 1g. b. of the
13 statutes, as created by this act, shall have terms ending on June 30, 2018. Of the
14 members specified in section 38.08 (1) (a) 1g. a. of the statutes, as created by this act,
15 who are appointed under this paragraph, one member shall represent employers
16 with 15 or more employees and one member shall represent employers with 100 or
17 more employees and one of those members shall represent employers who are
18 manufacturing businesses. The members appointed under this paragraph shall
19 replace the members of the district board appointed under section 38.08 (1) (a) 1.,
20 2009 stats., whose terms expire on June 30, 2015.

21 (3) Notwithstanding the requirements for membership on the district board
22 governing the Milwaukee area technical college under section 38.08 (1) (a) 1g. of the
23 statutes, as created by this act, any member who is serving on or appointed to the
24 district board on the day before the effective date of this subsection may continue to
