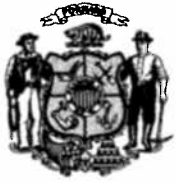

5 If any provision of this act is found to violate any provision of federal law or if any  
6 provision of this act jeopardizes or threatens any federal license the Milwaukee area  
7 technical college holds, the act is null and void.”.
