Assumptions Used in Arriving at Fiscal Estimate

There is no fiscal impact on the changes proposed. The equipment used in a food processing plant will be reviewed by the same individuals that will review equipment used in dairy plants. The standards are very similar. Many rules for food products incorporate 3-A Standards into their rules as appropriate. 3-A Sanitary Standards are considered the highest standards used in the food industry and are very detailed in the equipment they have standards for.

The only change needed will be a rewrite of current rules to incorporate the new definition (ATCP 70 and 80).
