- 2 **1.** Page 126, line 15: delete “one” and substitute “both”.
- 3 **2.** Page 126, line 16: delete “applies” and substitute “apply”.
- 4 **3.** Page 126, line 17: after “impacts” insert “on the mining site or, if the
- 5 exemption will result in significant adverse environmental impacts on the mining
- 6 site, the applicant will offset those impacts through a mitigation program, as
- 7 provided in s. 295.60 (8), through the measures provided in s. 295.605, or through the
- 8 conservation measures provided in s. 295.61”.
- 9 **4.** Page 126, line 18: delete lines 18 to 21 and substitute:
- 10 “2. The exemption will not result in significant adverse environmental impacts
- 11 off of the mining site.”
