Hi Cathlene,

On behalf of Rep. Kleefisch, would you please make the following modification to LRB a0928/1:

- Instead of deleting lines 1-8, modify these lines so that they specify that s. 943.13 (1m) (c) 2. and 4. do not apply to a person on the grounds of a school who is employed in this state by a public agency as a law enforcement officer and to whom s. 941.23 (1) (g) 2. to 5. and (2) (b) 1. to 3. applies, to a qualified out-of-state law enforcement officer, as defined in s. 941.23 (1) (g), to whom s. 941.23 (2) (b) 1. to 3. applies, or to a former officer, as defined in s. 941.23 (1) (c), to whom s. 941.23 (2) (c) 1. to 7. applies.

I listed both s. 943.13 (1m) (c) 2. and 4. because it is not clear to me which of these subdivisions a school district posting its grounds would fall under. Maybe it would be better to just specify in the amendment that a posting prohibiting weapon possession on school grounds does not apply to these individuals?

1. Page ²1, line 3: delete "1., 1m.,".

2. Page ²1, line 3: delete ", 3., and 5." and substitute "and 4."

3. Page ²1, line 4: delete "person who is" and substitute "law enforcement officer".

4. Page ²1, line 4: delete the material beginning with "as a law enforcement" and ending with "and to" on line 5 and substitute "to".

5. Page ²1, line 8: after "applies" insert "if the law enforcement officer, the qualified out-of-state law enforcement officer, or the former officer is in or on the grounds of a school, as defined in s. 948.61 (1) (b)".
