Here is a DNR drafting request for the 2013-2014 Legislative Session.

Publically disclose business name and address of licensed dry cleaners. The Department of Revenue does not have the authority to disclose information necessary for the Department of Natural Resources to run its dry cleaners clean-up program. They cannot publically disclose the names and addresses of licensed dry cleaners. Without this information DNR is unable to fairly regulate all dry cleaners. Add language to Ch. 77.9964 to ensure that fees are being fairly paid by all dry cleaners and to comply with statutory provisions that dry cleaning solvent be distributed only to licensed dry cleaners.

SUBJECT: Proposed Statutory Change to Ch. 77.9964: Public Disclosure of Licensed Dry Cleaners

Under current statute, DOR is prohibited from disclosing the names and locations of licensed dry cleaners. In December 2011, the Governor's Dry Cleaner Council recommended\* to the Governor and Legislature that DOR publish quarterly a list of all licensed dry cleaners. The purpose of this recommendation is to ensure that dry cleaner fees are fairly paid by all dry cleaners and obtain compliance with state statutes that require solvent be delivered only to licensed dry cleaners. The attached Legislative Proposal Form sets out the rational and proposed statutory language to allow disclosure of licensed dry cleaners.

#### 1. Problem/Issue

Currently, DOR does not have the authority to publically disclose the business name and physical address of licensed dry cleaners in Wisconsin. DOR and DNR are in agreement that publishing a list of licensed dry cleaners would be beneficial. The purpose of this recommendation is to ensure that fees are being fairly paid by all dry cleaners in the state and to comply with statutory provisions that dry cleaning solvent only be distributed to licensed dry cleaners.

#### 2. Description of Legislation

Add language to Ch. 77.9964, Stats:

"A current and regularly updated list, made available on paper and on the department's Internet Web site, of license holders that minimally includes detailed information on the business name, address where dry cleaning occurs, contact person, and date of license issuance for every dry cleaning facility issued under s. 77.9961."

Strike: Reference to Ch. 71.78(1) to (4), Stats. from Ch. 77.9964(2), Stats.

#### 3. Background

The Dry Cleaner Environmental Response Fund (DERF) has experienced significant revenue shortfall (up to \$1 million/yr) since 2007. The DERF helps protect the environment as well as the viability of small dry cleaner businesses. The Governor's Dry Cleaner Council recommended in December 2011 that the list of currently licensed dry cleaner businesses be made available to the public. This is necessary for two reasons:

- a. A publically available list would provide the public knowledge of which dry cleaner businesses are licensed and reveal which businesses are not licensed. This would allow the public to report unlicensed dry cleaners and provide DOR the opportunity to collect additional dry cleaner fees.
- b. Chapter 299.47, State stats., requires that suppliers of dry cleaner solvent may not sell or deliver solvent to any dry cleaning facility unless that facility is licensed. The penalty for such a sale is not more than \$500 per violation. A published list of licensed dry cleaner businesses would allow suppliers of dry cleaning solvent to more easily comply with this provision of the statute.
