



**ASSEMBLY AMENDMENT 1,
TO ASSEMBLY SUBSTITUTE AMENDMENT 1,
TO ASSEMBLY BILL 549**

March 7, 2014 – Offered by Representative KOOYENGA.

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 1, line 4: delete “and”.

3 **2.** Page 1, line 5: after “program” insert “, and making an appropriation”.

4 **3.** Page 1, line 6: before that line insert:

5 “**SECTION 1d.** 20.255 (2) (fm) of the statutes, as affected by 2013 Wisconsin Act
6 20, is amended to read:

7 20.255 (2) (fm) *Charter schools.* A sum sufficient to make the payments under
8 s. 118.40 (2r) (e) to charter schools under s. 118.40 (2r) (e) other than charter schools
9 authorized under s. 118.40 (3) (f).

10 **SECTION 1f.** 20.255 (2) (fn) of the statutes is created to read:

11 20.255 (2) (fn) *Replicated charter schools.* A sum sufficient to make payments
12 under s. 118.40 (2r) (e) to charter schools authorized under s. 118.40 (3) (f).”.

1 **4.** Page 1, line 6: delete “**SECTION 1**” and substitute “**SECTION 1m**”.

2 **5.** Page 2, line 25: after that line insert:

3 “**SECTION 4m.** 118.40 (2r) (e) 2n. of the statutes, as created by 2013 Wisconsin
4 Act 20, is amended to read:

5 118.40 (**2r**) (e) 2n. In the 2014–15 school year, ~~from the appropriation under~~
6 ~~s. 20.255 (2) (fm)~~, the department shall pay to the operator of the charter school an
7 amount equal to \$8,075 multiplied by the number of pupils attending the charter
8 school.

9 **SECTION 4p.** 118.40 (2r) (e) 2p. (intro.) of the statutes, as created by 2013
10 Wisconsin Act 20, is amended to read:

11 118.40 (**2r**) (e) 2p. (intro.) In the 2015–16 school year and in each school year
12 thereafter, ~~from the appropriation under s. 20.255 (2) (fm)~~, the department shall pay
13 to the operator of the charter school an amount equal to the sum of the amount paid
14 per pupil under this paragraph in the previous school year; the amount of the per
15 pupil revenue limit adjustment under s. 121.91 (2m) for the current school year, if
16 positive; and the change in the amount of statewide categorical aid per pupil between
17 the previous school year and the current school year, if positive. The change in the
18 statewide categorical aid per pupil shall be determined as follows:

19 **SECTION 4r.** 118.40 (2r) (e) 4m. of the statutes is created to read:

20 118.40 (**2r**) (e) 4m. The department shall make payments under this paragraph
21 to an operator of a charter school authorized under sub. (3) (f) from the appropriation
22 under s. 20.255 (2) (fn). The department shall make payments under this paragraph
23 to an operator of a charter school other than a charter school authorized under sub.
24 (3) (f) from the appropriation under s. 20.255 (2) (fm).”.
