

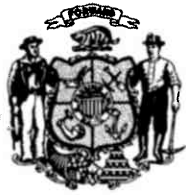

**Analysis by the Legislative Reference Bureau**

Under current law, \$442,400 in general purpose revenues (GPR) is appropriated to the Department of Workforce Development (DWD) in each of fiscal years 2013-14 and 2014-15 for the implementation and operation of youth summer jobs programs in first class cities (presently only Milwaukee). This bill appropriates an additional \$1,000,000 in GPR to DWD in each of those fiscal years for that purpose.

For further information see the *state and local* fiscal estimate, which will be printed as an appendix to this bill.

**The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:**

3 **SECTION 1. Fiscal changes.**

4 (1) YOUTH SUMMER JOBS PROGRAMS. In the schedule under section 20.005 (3) of  
5 the statutes for the appropriation to the department of workforce development under  
6 section 20.445 (1) (fm) of the statutes, as affected by the acts of 2013, the dollar  
7 amount is increased by \$1,000,000 for the first fiscal year of the fiscal biennium in

1 which this subsection takes effect for the purpose for which the appropriation is  
2 made. In the schedule under section 20.005 (3) of the statutes for the appropriation  
3 to the department of workforce development under section 20.445 (1) (fm) of the  
4 statutes, as affected by the acts of 2013, the dollar amount is increased by \$1,000,000  
5 for the second fiscal year of the fiscal biennium in which this subsection takes effect  
6 for the purpose for which the appropriation is made.
