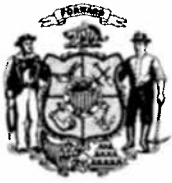

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 1, line 2: before “reports” insert “review of the one- and two- family  
3 dwelling code by the department and”.

4 **2.** Page 2, line 19: after that line insert:

5 “**SECTION 2m.** 101.63 (5) of the statutes is amended to read:

6 101.63 (5) ~~Biennially review~~ Review the rules adopted under this subchapter  
7 once every three years.”
