1 AN ACT *to amend* 16.75 (3m) (c) 1. and 16.75 (4) (c); and *to create* 16.75 (3m) (a)  
2 5. and 16.75 (3m) (bm) of the statutes; **relating to:** state procurement plans for  
3 amounts paid to small businesses.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

4 SECTION 1. 16.75 (3m) (a) 5. of the statutes is created to read:  
5 16.75 (3m) (a) 5. "Small business" means a small business as defined by the  
6 federal small business association.

7 SECTION 2. 16.75 (3m) (bm) of the statutes is created to read:  
8 16.75 (3m) (bm) The department, any agency to which the department  
9 delegates purchasing authority under s. 16.71 (1), and any agency making purchases  
10 under s. 16.74 shall develop a plan that at least 10 percent of the total amount  
11 expended under this subchapter in each fiscal year is paid to small businesses.
