TO ASSEMBLY BILL # 95

April 8, 2013 - Offered by Representative Sanfelippo.

1	At the locations indicated, amend the bill as follows:
2	1. Page 9, line 11: delete "500,000" and substitute "500,000 750,000".
3	2. Page 11, line 10: after that line insert:
4	"Section 11e. 59.17 (2) (bm) 1. (intro.) of the statutes is amended to read:
5	59.17 (2) (bm) 1. (intro.) In any county with a population of 500,000 750,000
6	or more, appoint the following persons:".

3. Page 11, line 22: after that line insert:

"Section 12e. 59.17 (2) (br) of the statutes is amended to read:

59.17 (2) (br) In any county with a population of less than 500,000 750,000, appoint and supervise the heads of all county departments except those elected by the people and except where the statutes provide that the appointment shall be made by other elected officers. Notwithstanding any statutory provision that a board or commission or the county board or county board chairperson appoint a department

head, except s. 17.21, the county executive shall appoint and supervise the department head. Notwithstanding any statutory provision that a board or commission supervise the administration of a department, the department head shall supervise the administration of the department and the board or commission shall perform any advisory or policy—making function authorized by statute. An appointment by the county executive under this subsection requires the confirmation of the board unless the board, by ordinance, elects to waive confirmation or unless the appointment is made under a civil service system competitive examination procedure established under s. 59.52 (8) or ch. 63. Any department head appointed by a county executive unless the department head is appointed under a civil service system competitive examination procedure established under s. 59.52 (8) or ch. 63.".
