Hi Rick,

We would like to make a drafting request that I believe would fall under one of the areas you work on. We would like to get a bill draft that would reinstate the statutory language relating to the permissible use of funds in the budget stabilization fund. According to information we received from the Fiscal Bureau, it appears that there was language enacted as part of the authorizing act for the budget stabilization fund (1985 Act 120) that reserved moneys in the account for periods of below-normal economic activity when actual state revenues fall below estimated revenues under the budget act. This restriction on use of the rainy day fund was repealed under 2001 Act 16.

If you could put together a draft that would create this statutory limit again, that would be great.

SECTION 59m. 20.855 (4) (r) of the statutes is created to read:

20.855 (4) (r) Transfer from the transportation fund to the general fund. From the transportation fund, the amounts in the schedule to be paid into the general fund. The amounts may be paid at such intervals during each fiscal year as the secretary of administration deems appropriate or necessary.

SECTION 59n. 20.855 (4) (r) of the statutes, as created by 1985 Wisconsin Act (this act), is repealed.




