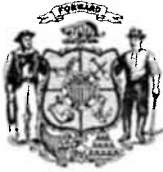

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 4, line 18: delete “18 unless any of the following applies.” and  
3 substitute “26.”.

4 **2.** Page 4, line 19: delete lines 19 to 22.

5 **3.** Page 9, line 5: delete lines 5 to 13 and substitute:

6 “SECTION 14m. 66.0137 (5) (c) 3. of the statutes is repealed and recreated to  
7 read:

8 66.0137 (5) (c) 3. An individual is not a dependent child for the purposes of  
9 subd. 1. or 1m. after the individual reaches the age of 26.”.
